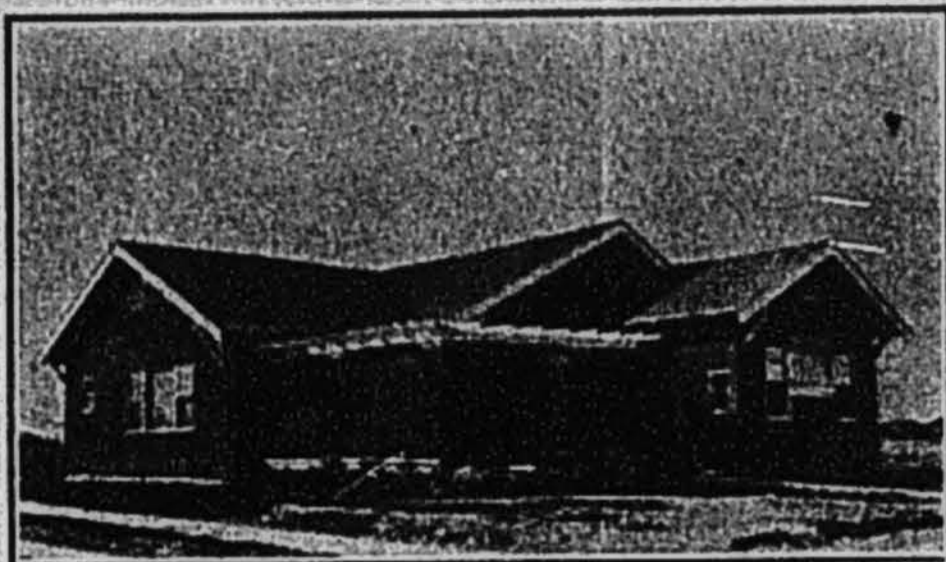

In balancing the books and accounts of the Normal Height Imp. Assn I find that there is a ballance of \$13.25 due the water co. and that they have paid \$15.00 during the year. This matter was taken up at the last meeting of the board of Directors. The amount of water used averages about 25 or 30¢ a month.

Mr Fletcher we believe you can give us some assistance, in this, as the conditions and times at the present are such that we have hard times to pay the expence of keeping the building, we wish that if you

could see your way clear, to lower the minimum of rate paid for water to about .75¢ or what you think would be fair for the amount used and we will try and have the bills paid regular.

Please let me know what you can do for us. We will greatly appreciate your effort.

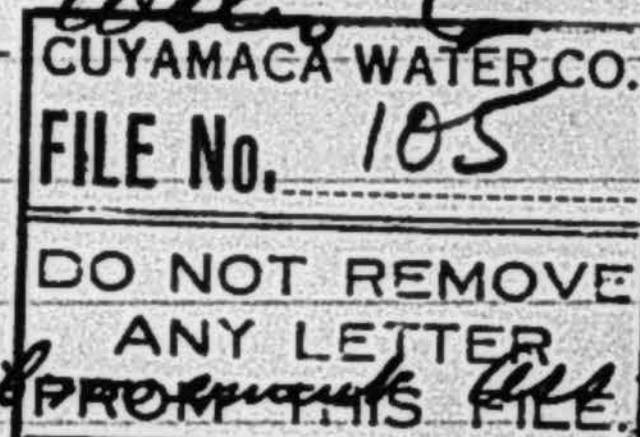

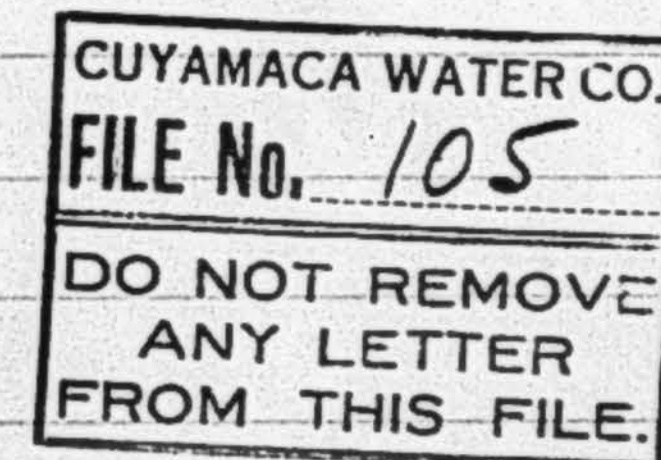
