Dear Mrs. Craft:

In submitting the attached invoices I would like to call your attention to the invoice dated October 5th.

It became evident sometime ago that changing float valves each time one of the coils refused to refrigerate, would never permanently cure the carbon troubles in this system. Therefore, instead of merely changing float valves I purchased a Fedders coil and a Frigidaire coil, and whenever one of your coils stops working I replace it with another coil, take the old coil to my shop, wash it out thoroughly with gasoline to remove all of the carbon, then I bake it in an oven to remove the gasoline and moisture. Then after I have reoperated the float valve, the coil is as good as new and ready to go back in whatever apartment that goes wrong next. You will readily see that by continuing this process, I will eventually rid the system of the carbon, which is causing the trouble.

The usual charge for changing a float valve runs from \$3.50 to \$5.00, and a complete overhaul of a coil runs about \$10.00. By having these extra coils, I am able to work them over in my shop during spare time and, therefore, can make a price of \$5.00 each for a complete reoperation.

With reference to the Frigidaire machine, we took it entirely apart, and in building it up again found the receiver, or tank which holds the liquid, was almost entirely filled with carbon and we boiled it for over a week in a caustic soda solution. Every part has been either replaced or worked over. The water cooled cylinder head has been added, which will materially cut down the formation of carbon.

During the time I had your machine out and my own machine in its place, I discovered that the waste water from the old machine was going somewhere under the building, where no doubt it was rotting any wood it came in contact with. In view of the fact that your water bills have been high in the past, I decided to pipe this water out to the "frog pend", or whatever you call it, in the patio. I dug a trench under the lawn and under a sidewalk and laid a pipe in it, and at the present time the water is going into this pool, making it unnecessary for your gardener to sprinkle this place.

I made no charge for this work because I was not authorized to do it, and when I discovered where the water was going it was too late to get in touch with Mr. Fletcher.

The machine now only runs about two-thirds of the time, so you should notice a large reduction in your power bill. It only uses about one-half as much water as formerly to do the same amount of work, and since this water is used over again to water the lawn, your water bill should be considerably lower.

I feel that we have done a very thorough job and that we have gone a long way towards clearing up the troubles you have had in the past, and I am sure that the money this has cost you will be repaid thru lower power bills, water bills and repair bills, and better satisfied tenants.

Dear Mr. Fletcher:

We have completed the reoperation of the refrigeration equipment in your Madrid Gardens Court, Glendale, and believe it will operate without any further trouble.

There was so much muck in the Fedders coils that our chemicals wouldn't do the trick, so we had them sandblasted. We found the trays from the Fedders coils in fairly good shape. The tinning seems to be better than that on the Frigidaire coils. We, therefore, had the twenty-four Frigidaire trays retinned at twenty-five cents each, and replaced a few of the tray fronts. The tinning and tray fronts are being charged to you at cost price, over and above the agreed price for reoperating the job, as per our conversation over the telephone.

The compressor developed a knock a few days before we took it out and since we did not want to take the time to overhaul it, we installed one which we had in stock.

As this job took nearly a week longer than we expected and cost a great deal more than we expected, due to the extra labor, it has put a decided crimp in our finances. Therefore, it would be very much appreciated if you can give this invoice your usual prompt attention.

You may rest assured that we will take care of you in case anything should go wrong, as we intend to stand back of this job.
