Dear Dr. Szilard:

Thank you for sending me your letter of July 21 and the attached draft of the full-page ad of the "Democrats Against Dean Acheson".

For various reasons which I would prefer to discuss with you in person, I do not believe that this ad would be effective or would strike the right note with Democrats who need to be reached here in the Senate.

For that reason I have refrained, as you suggest I should under such circumstances, from sending copies on to Senators Mansfield and Fulbright. I am returning them to you so that you may do so on your own initiative if you wish, but frankly, I would caution against it.

The decision not to go into Iran seems basically to have been made, and I am dubious about the use of a public statement on it.

Attached is the statement Senator Humphrey made this week on the Middle East situation. I assume you saw his statements in the Record for June 14 and June 16.

We had a long and interesting evening with Ben Cohen, Bob Nathan, Joe Rauh and others on the Middle Eastern situation two nights ago. There were as many viewpoints expressed as there were persons present.
