Time extension okayed over Moreno's protest

Southwestern College trustees this week twice overrode lone dissenter Benjamin Moreno's negative vote and okayed a request for a time extension from a contractor who brought in a job 59 days late.

The board turned down an administration recommendation that Deytime Construction Co. be penalized \$50 a day, for a total of \$2,950, when the contractor brought in a request for a time extension just before the meeting started.

The contractor cited failures by his subcontractors to meet deadlines as the reason for most of his late time. The company began the \$66,300 contract for construction of stadium restroom facilities in mid-June.

Moreno, who voted for the penalty, said he felt that the contractor is responsible for his subconstructors.

Although trustees granted the extension, they did agree that the contractor should be penalized the cost of the college's having to rent portable toilets during the football season.

Moreno voted against this motion, too.

That cost, said Business Manager Verne Wolfe, has not been totally learned yet, but final figures are due this week.

Moreno enters District 1 race

Banjamin J. Moreno, a member of the Board of Trustees of Southwestern College, has announced he is a write-in candidate for the board of supervisors in District 1.

Moreno, 38, a program control specialist at Convair for the past 17 years, became a write-in candidate at the urging of the Mexican-American Political Assn. (MAPA) and South Bay area residents.

"They wanted someone who would be accountable to the Mexican-American community," said Moreno. He paid the \$320 filing fee to qualify as a write-in candidate just before the dealine last Friday.

Five other persons, including the incumbent, Jack Walsh, are campaigning for the District 1 post and their names will appear on the ballot in Tuesday's primary election.

Moreno has been endorsed by MAPA and a group of residents in the Castle Park area in South Bay who he said "are concerned about the lack of representation at the county level."

"I just couldn't turn them down," he said.
Married and the father of

five children ranging in age from four months to 17 years, Moreno is a life-long resident of the area. The family lives at 1239 Orde Court, in Chula Vista.

Moreno served in the Navy from 1950 to 1954 and attended San Diego City College and a local business college.

He was appointed to the Southwestern College Board of Trustees in 1969 to fill a vacancy and was elected to a four-year term on the board in April 1971.

He has been active in youth activities, including serving as a Little League coach for 11 years and serving on the board of directors of a Mexican-American Boy Scout Council.

Moreno is a member of the Narcotics Prevention and Education Systems Board of San Diego County and serves on the board of directors of the oSuth Bay-Otay YMCA.

Moreno never looks back; Blank second

From the time the first returns were telephoned to the lobby of Southwestern College's administration building, incumbent Benjamin J. Moreno led with a healthy margin.

Trailing behind Moreno, but well in front of other candidates was contender Bill Blank, former Imperial Beach mayor, making his first bid for a college board seat.

Moreno, appointed 18 months ago, was also making his first bid for election.

According to totals from the county Registrar of Voters' office, Moreno and Blank, of five names on the ballot, logged impressive tallies of 9,273 and 8,077 votes, respectively.

BLANK AND MORENO begin their four-year terms in July. Blank will assume the seat held by Dr. E. Morris Hayes, who sits on both the Sweetwater High School and the college boards, a holdover from the time both districts shared the same trustees.

Hayes chose to run for reelection to the high school board and will be serving there for another term, as a result of his win Tuesday night.

The other two candidates, Mrs. Consuelo Rubio and Mrs. Riette Ormond, trailed far behind in the field and finished with under 2,000 votes apiece.

TO OBSERVERS, however, the real surprise of the college race came as tallies began to go up on the board for college instructor Annjennette McFarlin, who withdrew from the race in favor of Moreno a week after filing closed.

Votes came in for Miss McFarlin steadily all night. By the time the last precinct was in, around midnight, her tally was third highest on the board, with a total of 3,454 votes.

Miss McFarlin, when she notified The Star-News of her withdrawal from the race, said she didn't feel she was well-known enough in the area to run with any success.

Her name appeared on the ballot because she did not notify the registrar of voters until ballots had already been printed.

"because the campaign would have been int esting and there might have been so eone elected to the board who cares a out students."

"I want to thank all the people who voted for me," she added, "I'm glad it happened because it shows that people want a change and people care about electing trustees who are concerned with students."

FIRST RETURNS began coming in at 8:45 p.m. Tuesday. Waiting out the long night with College President Chester DeVore and other college administrators were Moreno and Blank

Mrs. Rubio and Mrs. Ormond did not put in an appearance.

Miss McFarlin had gone bowling, a regular Tuesday night custom.

Moreno and Blank drank coffee and chatted with the 25 or so people gathered to wait out the returns. Wives and families came in later.

Both candidates were never far away from the board and eyed totals as they were erased and replaced after more telephone reports.

Moreno led the field in 47 of the 51 precincts. Blank, however, led in only one of his home precincts, which voted at Central School. Other precincts where Blank led were 3709 Duffy Way, Chula Vista High School and Cook Elementary School, all in Chula Vista.

ALSO ON HAND were trustees Dr. Gordon Browning and Mrs. Marilyn Lassman, whose terms expire next year.

The fifth trustee, Dr. Robert Frazer, did not appear.

Browning, calm and at ease in sports clothes, breezily entered and extended his sympathies to Moreno, adding it was nice for him "not to have to sweat it tonight."

Returns came in steadily all night, with virtually no change in the pattern, except for the four precincts already mentioned.

Around 11 p.m., Blank and his wife left to put their children to bed.

By then, some 47 precincts had reported and Blank issued his victory statement.

HE ADMITTED he had not been too worried about winning the election.

"I felt from the beginning I had something of a lead over Mrs. Rubio and Mrs. Ormond," he said, "because I had previous political experience and knew a great many people. I felt that since I started ahead and if I could campaign as much as they did, I would probably end up ahead."

He added that the campaign had been a "very pleasant one," and that all candidates ended up good friends.

"I'll look forward to working with the board members and other candidates, and I intend to seek their counsel on issues."

MORENO, always calm-looking, could not hide the exhaustion that crept into the corners of his eyes and that showed on his face as the night wore on.

It was not until 50 precincts were in that Moreno acknowledged victory.

Sitting at a conference room table, he covered his eyes with his hands and collected his thoughts after three months of rigorous campaigning.

Moreno was perhaps the hardest campaigner in the college race. He was present for all candidate forums, small coffees and other gatherings with

He was even known to fly into town from a company assignment to attend a forum.

"WE TRIED to keep it low-key at first," he said of preliminary campaign strategy, "until all the people started filing against me. I knew that even though I was first on the ballot, I would be at a disadvantage with Ormond and Rubio as two of the other names on the ballot.

"Had I not worked as vigorously and had not the people who worked for me worked as hard as they did, I would not have won.

"Many individuals and organizations made this victory possible, but I still firmly believe, and I'm not throwing roses, in anyone's direction, that if it had not been for the local media and its constant reminder that 25% of the population in this area is Mexican-American, we would not have six Mexican-Americans on six school boards in the area.

"THE LOCAL MEDIA has done this. But by the same token, I want to say I will defend vigorously any individual or organization against the local media.

"But I keep coming back to the media. Without it, there would have been no April 20, 1971. I am here now because of it. Because it continually reminded residents of this characteristic of our community. Since 1960, we have been trying to elect Mexican-Americans to school boards. I have personally managed four of the campaigns.

"I know, and I expect, that I'll be critized by the media for some positions I must take. I know that the media has hurt some individuals, but it has made residents aware of this deficiency.

"Most of my work in the last year and a half has been for Mexican-Americans because that was an unjust deficiency in our system.

"I AM GOING to continue to address my interest and concern in that area, as well as other minorities, the learning disadvantaged, vocational education, the returning veteran and women out of college, to name some.

"I pledge to continue to work for

"I pledge to continue to work for our community and to create a better educational system. I bring awareness of the characteristics of our community to Southwestern and I'll continue to be a working trustee not a ribbon cutter.

"And, if people want to continue to assess my achievements as a hyphenated American, I'll keep the tally. But I'd rather not. I hope that some day we won't have to use the hyphens, because as a trustee I'm working for all of the community."

MAPA slates tardeada for hopefuls

Candidates sponsored by the National City chapter of the Mexican-American Political Assn. (MAPA) will be honored at a party Sunday at the VFW Hall at 541 E. 24th St., National City.

Herman Baca, MAPA chairman, said his group and the Southwestern College chapter of MECHA, a Mexican student's organization, are sponsoring the tardeada (afternoon party) from 1 p.m. until 6 p.m. The candidates are all expected to appear at 3 p.m., Baca said.

Candidates endorsed by MAPA for the National School District board are Frank Perez and Robert Baker; for Sweetwater Union High School District, John McGuane and Charles Hess; for Southwestern College, Bill Blank and Ben Moreno.

Moreno hits campaign trail to tell views

Benjamin J. Moreno, who was appointed in 1969 to the Southwestern Community College Board and is now seeking election to a full term, was guest of honor at several activities in the South Bay.

At a dinner featuring Filipino-American cuisine and entertainment hosted by Mrs. Paz Washe of Chula Vista, Moreno said, "Denying the opportunity for a college education to any student is like having a cure for cancer and not sharing it with others."

He explained the college's increased efforts to coordinate college-high school counseling and to improve the high school student visitation program. He emphasized the need for further advances in this area.

Moreno, a lifelong South Bay resident, pledged to continue to try to determine how Southwestern College could serve the entire South Bay community.

"As a community college," he explained, "Southwestern has an obligation to serve everyone in the South Bay. This includes identifying the immediate cultural, educational, and recreational needs of that community and continuing efforts to satisfy those needs, such as having experts speak on solutions to the drug abuse problem."



A native of Otay, Moreno and his wife live at 1239 Orde Ct. They have four children.

cational Opportunity Program)," Moreno said.

Other colleges, including Grossmont and San Diego Junior College, get more than Southwestern does, Moreno said. "And schools in the Watts area and even San Francisco get sums like \$100,000 EOP money."

Moreno said this happens despite the fact that Southwestern has more results to show from its expenditure of funds under the program than any other college in the state. "We are receiving the short end of this," Moreno said.

CANEDO SAID he will be busy for the next three months writing his doctoral thesis concerning testing to deter-

mine the IQ of Mexican-American students.

Canedo says he will go for the assembly seat, "If my party chooses me as its most qualified candidate."

Canedo, 30, teaches four languages at the Cal-Western campus of the U.S. International University. He was elected to the National District board in 1969 after an unsuccessful attempt for a board seat in 1967.

Observers see Canedo's political problem now as financing the expensive assembly district campaign.

Canedo is the son-in-law of a well-known National City couple, Mr. and Mrs. Ruben Rubio, long active in Democratic and city politics.

The Rubios are already preparing to go all out to help Canedo with his campaign if he decides to run on the Republican ticket. Moreno, Canedo may take on Deddeh Ilmound camp

Assembly race rumors not denied

Two South Bay men were noncommittal this week but did not deny reports that each is considering running next year on the Republican ticket for the seat held by Assemblyman Wadie Deddeh (D-Chula Vista).

Ben Moreno of Otay, a Southwestern College trustee, and Oscar Canedo of National City, a college language teacher and a member of the National School District board, both admitted discussing the possibility, either with party officials or private backers, of trying to oust Deddeh, who will be seeking his fourth term.


BUMPER STICKERS bearing the statement "Moreno in '72" are already seen on some vehicles, but Moreno says he does not know who is responsible for having the stickers printed and he does not know exactly what they mean.

Moreno said he has no ambition to become an assemblyman, "but I have never turned my back on a call to serve," he said.

Moreno, who received strong support for his college board seat from young Mexican-American activists of MAPA (Mexican-American Political Assn.) of National City, is featured as a speaker for a fund-raising dance next week for one of that group, Louis Natividad, a candidate for National City Council.

Although Moreno flatly denies it, political observers see his appearance in National City as part of his tentative buildup for a possible assembly campaign.

Moreno's considering to run against Deddeh on the Republican ticket (Moreno is a registered Democrat) is a evidence of the growing split

within the ranks of Mexican-American South Bay community leaders.

ERNEST AZHOCAR of National City, president of the board of the Sweetwater High School District, has been under attack recently from the activists. He is not expected to support Natividad for City Council.

Azhocar is Deddeh's liaison with the Mexican-American community, and is expected to support Deddeh again for re-election. Azhocar has sparked a number of bills that Deddeh authored and became laws aimed at improving the lot of Mexican-American students in California.

Moreno vehemently denies any rift with Azhocar, who personally introduced him to influential National City residents in the college board race and at whose business place most of

"I wish to emphasize," Moreno said, "that although I have been approached about running on the Republican ticket, I am by no means the only person being considered."

MORENO SAID he isn't even sure he would prefer an assembly seat to his position on the college board. He said he is unhappy about what he considers the lack of assistance to Southwestern College from the state, and he blames Deddeh and state Senator James Mills (D-San Diego).

"We are told over and over we have no problem in qualifying for state aid, so we put in for the \$75,000 we need, and we get only the \$10,000 we got the last year under the EOP (Edu-

Moreno enters supervisor's race

A last-minute write-in candidate for South Bay Supervisor was launched by the Mexican American Political Assn. (MAPA) in a surprise move this week.

Southwestern College trustee Ben Moreno, 38, appeared at the Registrar of voters office in San Diego about three hours before the filing deadline Friday, paid the \$320 filing fee and declared his candidacy.

SUPERVISORIAL candidates appearing to speak at the MAPA endorsing forum learned of the fifth candidate for the post now held by Jack Walsh, when they saw cars bearing "Moreno for supervisor" stickers drawn up in front of the MAAC headquarters where the forum was held.

The candidates, who had been advised tthat MAPA would endorse after hearing them speak, were reluctant to ask for the endorsement in the face of the evidence that MAPA was

fielding its own candidate.

Attorney William Zumwalt, candidate for supervisor from Point Loma, asked, "Is this a stacked dectk" Another speaker Frederick Drew, appearing for candidate Kile Morgan, mayor of National City, told the MAPA audience that he was speaking for himself when he advised that the organization needed some successes in supporting candidates.

Drew said, "Ben Moreno is a marvelous person but to throw him into the race now would be to distort the campaign and weaken the organi-

zation.

Drew told the audience that two of the candidates for supervisor are running neck-in-neck, apparently

referring to Walsh and Morgan. He said the MAPA endorsement might be the factor that tipped the scales for one of the candidates, thus giving MAPA political power with the new supervisor.

MORENO, CONTACTED by telephone following the meeting, said, "I don't think they (MAPA members) are under any illusions that I can win it but they do not want to waste their vote. They want to let the leading candidates know that they are concerned with real representation up town.

Moreno said he had been invited to

meet with MAPA members at Herman Baca's print shop two days ago. Moreno said he found his supporters working on signs and printed material for his campaign. Moreno says that he does not want to discourage the work that members of MAPA have done in getting involved in the political field in National

He said that MAPA began registering voters last October while working for Louis Natividad's campaigning for National City Council. He said the group put about 40 registrars in the field, registered around 3000 voters and did, I think, a great service to the city.

Moreno said his supporters have learned that the vote is more powerful than a bullet. They are learning to use the system — the ballot box — and they are really trying to make it work.

"My supporters would consider 50 votes more powerful than demonstrations, he said.

Moreno, who lives in Otay with his wife and five children, is employed by General Dynamics.

Moreno said that his candidacy is not just a Mexican-American thing, and I don't want it to appear that it is. He said the National City MAPA organization has brought in a Castle Park committee which will also support

his candidacy.

Moreno, after being appointed to the college board and serving 18 months, ran for the seat and took it easily in 1971

polling almost 10,000 votes.

The five candidates for supervisor are Walsh, Morgan, Moreno, Zumwalt, Tina Callahan, a registered nurse of San Diego, and John Nagey, president of the State Homeowners Assn.
