A SDPD police car pulled in behind me. I was handcuffed by Officer			
[REDACTED] and put into the patrol car. After an hour I asked to be			
taken out. When Officer [REDACTED] took me out he threw me down and began			
banging my head on the sidewalk. He put me back into the car and began			
punching me. He took me to jail and in a small room he began			
punching me some more in the face and head. He pulled my ear and ear-			
ing, causing it to get infected. He also kept threatening to get me			
if I reported him. He said if I reported him he would tell his kids			
to "get me".

I PULLED INTO THE DRIVEWAY OF FRIENDS HOUSE AT 26TH. & 'L' ST. A S.D.P.D. POLICE CAR PULLED IN BEHIND ME. I WAS HANDCUFFED BY OFFICER [REDACTED] AND PUT INTO THE PATROL CAR. AFTER AN HOUR I ASKED TO BE TAKEN OUT. WHEN OFFICER [REDACTED] TOOK ME OUT HE THREW ME DOWN AND BEGAN BANGING MY HEAD ON THE SIDEWALK. HE PUT ME BACK INTO THE CAR AND BEGAN PUNCHING ME. HE TOOK ME TO JAIL AND IN A SMALL ROOM HE BEGAN PUNCHING ME SOME MORE IN THE FACE AND HEAD. HE PULLED MY EAR AND EAR-RING CAUSING IT TO GET INFECTED. HE ALSO KEPT THREATENING TO GET ME IF I REPORTED HIM. HE SAID IF I REPORTED HIM HE WOULD TELL HIS KIDS TO "GET ME".
