

14th AUGUST. 1956

To ZENAG Village. Amended census and inspected. Returned to Mumeng.

INTRODUCTION:

This was a short patrol to complete the Mumeng Census Division which was started in March 1956 (Patrol Report Mumeng No. 5-55/56)

All villages can be reached from Mumeng Fatral Post in one hour or less and most of them receive frequent chort visits during the year.

NACIVE AFFAIRS:

Disputes and complaints in these villages are brought to Mumeng as they arise and it was not necessary to hold a Court for Native Affairs during this patrol. One dispute regarding damage to a garden by pigs was settled out of court.

Villages were generally clean and in reasonably good condition. PAMALABUS had by far the best village, being clean and well laid out with good houses and good sanitation. PERAKLES Village was rather dirty, particularly around the edges, and many old latrines and rubtish pits had not been filled in. Instructions were given accordingly.

All villages except MUMENGTAIN have Village Fund Society Accounts. Mumengtain have decided to start a village account but have not yet decided upon committeemen.

VILLACE OFFICIALS:

Village Officials in the area patrolled consist of -

- 6 Luluais
- 5 Tultuls
- 5 Medical Fultuls.

MUMENGTAIN and KUMALU officials are good. Other officials are generally better than those found further away from the station but could by ho means be termed cutstanding. PAMALABUS Tultul is absent at employment.

AGRICUL/TURE:

All villages are suffering from a seasonal food shortege which following the recent long dry period, is more severe than usual. Planting has recommenced following recent heavy rains but should the latter part of the dry season be as bad as the first half a serious shortage of food may result.

Main economic crop for the area is coffee. All villages except PAMALABUS have one established garden and a second garden prepared and awaiting seeds. A quantity of seed has been received and is now being planted in these villages. An Agricultural Field worker has been sent to PAMALABUS to commence a softee plantation there.

Small gardens of rice at Kumalu, Pamalabus and Zenag were complete failures due to the long dry season.

A quantity of White Spanish peanut seed has recently been received and issued to these villages for planting.

HEALTH:

Mr Turner, E.M.A. accompanied the patrol on some occassions and will be submitting a report on health.

EDUCATION:

21 boys and 3 girls from the area patrolled attend the Mumeng Village Higher School. All villages work regularly at the school cleaning and making gardens.

Attendances at Latheran Mission village schools are shown in Appendix 'a'. PEHAKLES has no school and some of the children travel about four miles each day to the Patep School. The Patep school takes only 14 from Peraklis and there are many boys and girls of school age who do not attend school.

CENSUS:

There is an increase of 41 on previous figures. Births (78) exceeded deaths (31) by 47. Migrations Out exceeded migrations in by 2. 4 Duplicate entries were located. All villages showed an increase on previous figures.



The main purpose of this patrol was to carry out a land investigation in the Snake Valley headwaters. This has been made the subject of separate correspondence. Foutine administration was carried out thile in the area.

Village sanitation leaves much to be desired. At BULANTIM ten men were convicted and fined under Native Administration Regulation 119 for failing to carry out the orders of the lolusi with regard to work on latrines and rubbish pits. None of the instructions given during the census patrol in January had been carried out and it was found necessary to order the replacement of every latrine and rubbish pit. Other villages were not as bad as this but some improvements had to be ordered in most villages. Village officials and their reluctance to make a complaint against any of their people are largely responsible for this state. The need for propper sanitation was stressed throughout the area and in particular the responsibility of village. officials to ensure that the work is carried out was made clear to all.

Court for Native Affairs was held only at BULANTIM as mentioned above. A number of disputes were settled out of court. Most of these were at MANCGA and LAGIS and referred to damage to gardens by pigs. The provisions of Native Administration Regulation 101 were also stressed throughout the area.

Officials of MANGGA, BOGOMATU and KWASANG expressed concern at the number of men returning from employment with little or no money, having lost it all atcards. They requested that heavier penalties be imposed in cases of gambling. They were informed that their to-operation in reporting cases of gambling would help considerably. They have been touring main centres of employment urging men from their villages to give up gambling.

The movement of BUGAI'AU village has been completed and the old village demolished. A rest house has been constructed at the new village. Work at BUGWEV village is proceeding very slowly, little having been done since the last patrol four months ago.

V_LLAGE OFFICIALS:

At MANGGA lulnai LAPOS was replaced by NAEONG in accordance with NA 14-3-13/1 of 7th day 1956.

BUGAI'AU, a village of 342 people, has only one active official. It is not clear whether luluai RANJI was dismissed from office or whether his hat was removed for the period of imprisonment in 1953. However, the hat was not returned to him and BUGAI'AU has been without a luluai since. Tultul TAMON has been been absent at employment for about two years. This leaves only one tultul who is aged and not very active. Recommendations regarding village officials for this village have been made the subject of separate correspondence.

AGRICULTURE:

<u>Subsistance crops</u>. Following an exceptionally dry period in what is normally the wet season, there is a slight food shortage in this area. The shortage has affected introduced vegetables such as potato, corn and cabbages more than the supply of st aple foods - yans and sweet potato. The shortage is not considered to be serious and now that rains have failen it should soon be overcome.

All villages have cleared and fenced large areas in preparation for the yam planting.

Economic cfors. Coffee is the main economic crop of this area. All villages have two coffee gardens The first gardens established are doing well. Seedings appear to have recovered from an initial setback in transplanting and are growing well and appear to be quite healthy. Shade is good and grass has been kept down. Second gardenr generally required some attention - replanting patches of shade which did not germinate or replanting some seedlings which died during the recent dry period. An Agricultural Field worker was left in the area with instructions regarding this work.

SANGAS village have, in addition to coffee, been growing rice and peanuts. They have harvested approximately 1000 lbs of rice and 300 lbs of peanuts.

MANGGA Village has started a small rice garden. European vegetables provide a small source of income for some of the people. Difficulties is getting produce to market limits the possibilities for vegetables

as an economic crop. Headwaters villages have established a large garden near GABENSIS on the Lae-Wau road so that they can get their produce into ma rket in Lac.

Work stopped on the Snake Valley Road at the end of June to permit people to give attention to their gardens. Work will be resumed again in January 1957.

As mentioned in the heading 'Mative Affairs' village sanitation leaves much to be desired. Aid Post Orderlies may be doing a good job in treating illness and injury but they obviously do not consider village sanitation to be any part of their work. I consider that to make a flyp-roof latrine cover withe, tools and materials available should be an essential part of their training. Not one latrine seen co uld be termed fly proof.

Ten natives were sent to the Native Hospital, Mumeng, from Mangga and Lagis. Most of these were cases who failed to obtain treatment from their Village Aid Post. EDUCATION:

The only education available to the children of this area is the usual Lutheran Mission village school of very low standard. A new rehealroom of Suropean materials has been built at IOMALOM village and will be opened shortly. Although the surroundings will be much more satisfactory for the school children I doubt if there will be any improvement in the guality of the education.





It could be seen from here that SIMINAPA Village the village where the patrol was to meet the Manyamya pa trol tomorrow - had long been abandoned. Decided to wait at KWEK for signs of the patrol.

26th SEPTEMBER.

At KWEK. Some people came in with food but all young men keeping well away from the camp.

27th LEPTEMBER.

At XWEEK. Contract with Menyamya patrol at YENPA. A few Women came in with food but most people could be seen removing their belongings to the bush.

28th SEPTEMBER.

Departed at 0530 hours to TENPA at 1200 hours. Met Menyamya Patrol in charge of Mr. Desailley.

29th SEPTEMBER.

With Menyemya patrol, shifted camp to MATAPA about one hour away.

30th SEPTEMBER.

At MATAFA working in conjunction with Menyamya patrol attempting to make contact with the people and assisting in the apprehension of persons wanted in regard to the SESERE-MANDI raids. Remainder of stores brought up from KATSTONG. For full details see Menyamya report.

INTRODUCTION:

The purpose of this patrol was to investigate reports of alleged nurders at SESERS-MANDI in the Lower Banir. SESERE-MANDI is in the area which comes under Mumeng Patrol Post and the raiders were from the Upper Banir which is in the Menyamya Sub-District. Consequently two patrols proceeded to the area - our from Mumeng and one from Menyamya. Menyamya Special Patrol Report of 25th October, 1956 has been submitted and deals with the apprehension of persons required with regard to the alleged murders and with conditions in the Upper Banir. It is not intended to duplicate information given in that report and this report should be read in conjunction with the Menyamya report.

NATIVE AFFAIRS:

During September the Tultui of BUNDI reported at Mumeng that there had been two murders at SESERE-MANDI. When the patrol arrived at SESERE it was found that over a month had elapsed between the alleged murders and the reporting of them. The reason given by the SESERE officials for their failure to report the murders was that the SESERE-MANDI people, although part of SESERE, lived in a small, isolated hamlet and have resisted the efforts of SESERE people and of previous officers to get them to move to SESERE village for their own protection. They have generally avoided contact with previous patrols and ha ve resisted mission influence and were therefore not considered by the SESERE officials to be worthy of protection.

Shortly after the two murders the people abandoned their old hamlet and constructed a new one much closer to SESERE. The new site is, however, still ebout half an hours walk from SESERE and will not give the people the increased protection that they would get if they joined with SESERE. The people were advised to build at SESERE where there would be a certain amount of safety in numbers. When the patrol left the area a constable was left at SESERE to assist the people of SESERE-MANDI in moving to SESERE should they decide to do so, or to ensure that proper village sanitation be provided at the hemlet and a good track be constructed between SESERE and SESERE-MANDI should they decide to remain at their present site.

One principal offender and seven accomplices were arrested by the two patrols. The principal offender, OMMBIC, is fight leader of the MATAPA people. It is hoped that these arrests will give the people of the Lower Banir some protection from further raids but it cannot be said that there is no further danger of raids by the Upper Banir people on those of the Lower Banir.

The first murder occurred on the night of the 23rd July. It being a fine night and with a full moon. SIKWOONBONAS of SESERE-MANDI slept outside his house with his two wives. He was attacked and struck in the right eve with an axe. Cne wife woke and recognised ORMBIO and AKAMEJEIO of NATAPA as the attackers. Next morning a search showed that the attackers had been accompa nied by a large number of men who had hidden in the bushes round the couse.


The second murder occurred on the 4th August. An elderly man, SERANGELEIS, left the village and descended to the creek for water. He was la ter found dead, having been struck in the head by an axe. There ware no witnesses to this incident. Footmarks showed that a number of men had been involved. ORMBIO, after his arrest, admitted to having taken part in this raid. The seven men arrested with ORMEID were MEMCHO, KAMIKIJO, MANDEMORIO, TEPAKUBIC, MAPIC, AMIFAU and MARANURACHIC, all of MATAPA. All have been sent to Lae where Court ection will be taken. Unfortunately AKAMEJEIO was not arrested. He, also, is an influential man on MATAPA who has received montion in previous reports.

TIMELKUBIO of KWE is believed to have accompanied the MATAPA men on at least one of the raids but unfortunately he was not located by the atrol. The fact that one of their men had been involved in the raids was probably the cause of the very timid reception of the patrol at KWEK for Mr. Makeford reported that the previous patrol received a good welcome and plenty of food was brought in.

At the time the patrol was in the area the Sesere Village Book could not be located so the census of Sesere and Katsiong was not amended. The book has since been located and this will be done when the Lower Watur crucus in amended in the near future.

People of KATSIONG expressed their desire to return to their old ground on the Tauri-Banir divide. They were advised sgainst such a move as they were forced off this ground by the GAATERA and since being in the Bamir have been raided by the SWATERA. Return to their old ground would undoubtedly lead to further trouble with the GWATERA.

INTRODUCTION.

Mr. E. Wilson, Regional Agricultural Officer, accompanied the patrol between the 29th January and 1st February. Mr. Wilson inspected land under consideration for alieration. He was also able to inspect a number of the coffee plantations in the area and gave advice regarding the work to be done on them.

Unfortunately the patrol had to be interupted on a number of occasions. This was necessary so that rations could be issued at Mumeng, a Dept. of Works employed could be accompanied while blasting on the Suake Valley read and also to meet Mr. Wilson at Mumeng.

This was the third patrol to the area since the census patrol of January - February 1956.

NATIVE AFFAIRS.

The area provided is close to Lae, Bulolo and Yau and has had many years of contact. Consequently many of the for seek employment in those centres. Census figures show that, of the adult male labour potential of 1807, there are 1042 absent at employment and schools. It cannot be said that the remainder are in their villages as there is a constant movement of men, women and children between this area and Lae, Buloio and Wau, leaving few people in the area to look after villages, gardens and roads. Any attempt to dissuade the people from this upless movement to the towns only makes then seek a different route so that they can leave the area unobserved Few complaints were brought before the pairol and most of these were minor matters whichwere settled out of court. In the Court for Native Affairs two cases of neglect of children under 14. two of failing to carry out a luluai's orders, one of a huluai failing to keep his village clear and sanitary and one of failing to appear for census were heard. Although the area is comparatively peaceful and law abiding, clearly most of the disputes are settled in the villages by the village leaders. In fact, the tultul of LAGIE was reprimended for attempting to prevent a man from bringing his complaint before the patrol.

People of SINAGEI complain d that the people of SIGAINO had made sorcery to destroy the SINAGEI yam gardens. They could produce no evidence of any kind and it would appear that the damage to the gardens has been caused by the exceptionally dry weather experienced in recent months.

Village sanitation bas isproved throughout the area except for the villages of AIYAYOK and GAMBIA. It was necessary to leave a constable at these villages to ensure that propper sanitation was provided - the village officials being completely incapable. Nearly every rubbish pit and latrine of both villages needed to be replaced.

Generally villages appear to be occupied only at the time of patrols and some other special occasions, while for the greater part of the time the people live in bush and gerden houses.

New rest houses have been completed at SINACEI, DAWONG, EUGWEV and BUGAI'AU.

VILLAGE OFFICIALS.

Iuluai KASIS of SANGAS is deceased. .. is recommended that MANGI be appointed as luluai to replace him. MANGI is comparatively young, is an ex member of the N.G.P.F. and has been selected by the people. I consider him to be the pest man available for the position.

At BUGAI'AU, GOLI was appointed Lulual in accordance with 14/3/13(1) of 5th October 1956. MANOK was appointed Lului oplace of TAMON in accordance with 14.1.5 of 20th Sept.1956

Village officials in the area leave much to be desired. As already stated the officials of AIYAYOK and GAMBIA are incluable of performing their duties. There are, however, no satisfallory replacements in the villages. Tultul SIUNG of RARI has considerable influence throughout the headwaters villages. Village Aid Posts are situated at TOKANEN, MAPOS, LOMALOX and MAMBUMP. If attendance at these aid posts was as good all the year round as it is at census time health would not be a problem. Attendance in normal times, however, is not nearly as good. Too often people are left until they are beyond, or almost beyond, aid before being taken to the aid posts. Quite often they are not taken to the aid posts at all. There is a marked tendarby to neglect to obtain redical aid for children and during the patrol two convictions were recorded for this reason.

TOKANEN, a village with an aid post, was one of the two villages in the area in which deaths exceeded births for the year - of the ten deaths in that village eight were children.

Village sanitation has improved over the last year but there is still room for further improvement. Constant supervision by officers and police is necessary to see that sanitatica is maintained. Aid Post Orderlies do not appear to consider the improvement of village sanitation to be any part of their work.

AGRICULTURE.

HEALTH.

Coffee is the main economic crop of the area. All villages have started two gardens of about 1,000 crees each.

The first gardens were started about two years ago. Generally they are doing well and a few trees in most are now beginning to bear. Fermanent shade is growing well and temporary shade is now being thinned but. A few of those forst gardens, however, were not entirely successful and at AIYAYOK and KWASANG they were complete failures. Places where they were only partially successful were MANGGA, BOGOMATU, LAGIS, TOKANEN and MAFOS. loss of soil through erosion on steep slopes was the cause of failure.

ATTAYON'S second garden suffered similarly and they are now practically without any coffee. During this patrol a suitable piece of flat land was selected for a third garden and an Agricultural field worker is now working with these people.

Second gardens received a setback in the long dry periods experienced during 1955. Some of the gardens have had seedlings transplanted and are doing well but in most cases nurseries have suffered in the dry weather. New nurseries have been established and gardens have a good covering of temporary shade but seedlings are not yet ready to plant out.

Considering both gardens, it could generally be said that the results have been good in the headwaters villages (ie above MAPOS) but have been rather disappointing in the lower villages (ie. MAPOS to KWASANG). An Agricultural Field Worker is constantly working in this division and actention will be given to these lower villages during the coming year. Throughout this patrol planting of coffee by individuals was encouraged but with little effect.

SANGAS Village have produced a small quantity of rice and peanuts. PATEP I have also recently planted rice and peanuts.

ROADS.

Nork has been resumed on the road through this valley. All villages have sent some mon to the KWASANG area where some difficult country is holding up progress. An employee of the Dept. of borks is assisting by carrying out blasting operations on Sunday mornings. Once past this difficult piece between hwaSANG and MANGGA there should be little difficulty in putting the road through to the headwaters.

EDUCATION.

A school is badly needed for this area. Only 10 males from this valley are attending Administration schools. 50 males and 20 females are attending mission schools outside the area. For the remaining 1200 children there are only the village mission schools of very doubtful value under pative mission teachers.

CENSUS.


Census figures give a total of 7,794 for the census division. This is an increase of 148 on previous figures.

Births exceeded deaths by 171. Migrations Out exceeded migrations in by 28. Figures for BULANTIM village could not be reconcided with last years figures - giving an increase of 7 in this years total. 2 duplicated entries were located.

With the exception of TOKAMEN and SINAGEI, all villages showed in excess of births over deaths (TOKAMEN decrease of 4, SINAGEI decrease of 1).

Migration Out figures include 13 male and 14 female migrations from BULANTIM and LOMALOM to the coastal village of BUMATU. As the BUMATU luluai was present with the village book particulars have been put on the 'General Information' pages of the book for the use of the rext officer patrollin / hat area.

END OF PATROL.

INTRODUCTION:

The patrol was originally intended as a general one of the Lower Watut Census Division. However acting on instructions received from the District Officer Lae the patrol proceeded direct to the Banir River area and linked up with a patrol led

by Mr. Desail v s/2 D.O. Menyamya. From there normal patrolling was resumed back through the Lower Watut and some Middle Watut villages.

NATIVE AFFAIRS:

General;

Throughout the whole area only minor complaints and disputes were bought before the patrol and as usual the Watut appears to be free of serious crime.

Land disputes are numerous and in many cases these have been bought up several times with previous officers. Most of the trouble has apparently arisen from some villages moving down from the ridges and settling on the various rivers on land not their own.

Villages in the Middle Watut have completed their moves

from the heights and the new places along the river are ercellent In the Lower Watut only one village Cunots remains on a ridge top; the rest being built along the Watut River or its tributaries.

Village surroundings in all cases were satisfactory but nore frequent maintainance of tracks is needed.

Village Officials; These leave much to be desired and in many cases it is obvious that they do not ave much influence with the people.

ECONOMIC DEVELOPEMENT:

Loffee:

Eight villages, Taiyek, Galawo, Kapin, Dambi, Dangal, Guaupu Biamina and Piu each have about 1000 trees at present with shade well established.

Due to the change over of officers at Multing since February , coffee extension hasbeen neglected somewhat. Goffee planted in nurseries het grown too large to transplant with success and in most cases has been left unprotected and has been affected by the sun, the leaves turning yellow and dying off. The Agricultural Field Worker who works in the area does

not appear to take much interest in his work. Further seed is required for the area.

Coconuts:

The Lower Vatut Villages of Maralin in ,Babwuf,Tsili Tsili Dungatung,Wuruf and Pesen all have groves of palms.No coprais produced at present and the nuts are used as a supplementary item of diet only.

Mining :

Gold preduction has been stepped up considerably throughout both sub-divisions and rayments during the first six months of this year have exceeded one tousand pounds.

six months of this year have exceeded one tousand pounds. All villages are interested in setting up a trade store within the village, financing it initially from the proceeds of gold production. The village of Kapin. I. and several others have already done this. In each case a large proportion of the money seems to finally find its way into the bands of the person who "leads" the mining enterprise and also has the running of the store. Very little money moves through the Village Society Fund Accounts.

Fund Accounts ...

RUADS:

The Middle Watut road past Bangalumis now non existent due to numerous earth slips. Nothing was done regarding the maintainance of this road past Bangalum as it would appear to be a full time job for all the villages concerned. No work as been done on the Lower Watut road since the last patrol.

AGRICULTURE:

All gardens in the area were producing we to the staples and European vegetacles.

HEALTH:

Mr. Turner E.M.A. accompanied the patrol and his report

Mr. Turner E.M.A. accompanied the patrol and his report gives details of bealth in the area. The people of the area all appear averse to attending the Aid Posts at Marilinan, Zinimp. Kapin and Dambi , for treatment. It is only when the sick are nearly lead are they bought in for treatment and then of course it is too late for anything to be done. A blitz on deseased dogs in the area and burning of dirty bloths would probably do much to lower the moder of cases of scables and sorps.

EDUCATION:

At last census twenty five children were attending the government school at Mumeng. The Lutheran Mission maintains schools of sorts at severalx villages.

AIRSTRIPS.

Teili Teili eirstrip is being regularly maintained and while the patrol was in the area one light arroraft used the strip.

BANK RIVER AREA: The patrol. proceeded to this area on instructions from the District Officer Lae. In meeting Mr.Desailly a/A.D.O. Menyamyars was it was found that the area was quet and that tribal fighting

it was found that the area and that the first was found that the area for two days had not broken cut . The patrol stayed in the area for two days during which time police were used in the capture of four suspected murderers in the Matapa area. A return was then made via Katsiong and Sesere

The two abovementioned villages were in good order and no serious crime has been reported here for some time The TulTul of Segere was taken with the patrol into the headwaters to act as interpreter. He has been used by all previous patrolr for this purpose and has proved bimself post reliable and helpfal.

SUMMARY

Konomic developement in the area appears to be well under way and the main one gold production is netting the people a fair return. Coffee plantions will have to be extended if reasonable returns are to be expected from them in the fut A further patrol to the Banir River in the near future would be desirable. future
