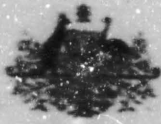

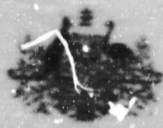

SAFETY PATROL REPORT NO 5/1973-74

Attached please find two copies of the above patrol report prepared by L.P.O. No 2396 plus a claim for camping allowance for patrols 4 and 5.

This patrol was mounted with the specific responsibility of clearing road on the Kung/Sik road after the visit of the Army blasting team, and to attempt to make the Giza rock face trafficable to four drive vehicles.

The patrol achieved more than I had anticipated and the road was open to approximately 3 miles past Maris village when I inspected work on November 10th. W/O Kain Ham and W/O Ham Ali are departing on November 12th to continue roadwork in this area.

The "movement" in the Koi area is the subject of field reports 1 and 2, and any further developments will be reported.
