Dear Dr. Strahlman: -

The news item from the San Diego Union of June 20, relative to the "noted goat gland specialist" John R. Brinkley of Milford, Kansas, has been read with interest. John Richard Brinkley, of Milford, Kansas, according to our records, was born in Reta, N. C., in 1885. He seems to have attended Bennett Medical College, Chicago, for three years, from 1908 to 1911, but was not graduated from that institution. Four years later (in 1915), he received a diploma from the Eclectic Medical University of Kansas City, Mo., and four years later still (in 1919) he received another diploma from the Kansas City College of Medicine and Surgery. Neither of these Kansas City institutions is reported in good standing with the Missouri State Board of Health. Our records show that Brinkley obtained a temporary permit to practice medicine in Arkansas in 1915; was licensed in Tennessee in 1915; in Kansas in 1916 and in Texas in 1919. Marly in 1920 Brinkley got a great deal of notoriety thru a number of sensational newspaper articles. It was claimed that Brinkley, by implanting the "interstitial" gland of a goat was performing surgical and medical marvels. Thus the New York American for March 14, 1920:

"Dr. J. R. Brinkley, head of the Brinkley-Jones Hospital and Training School for Nurses, at Milford, Kansas, has now furnished to the scientific world what are termed "ample proof" cases, that by injection of the fresh interstitial glands of the goat, sterile people may bear children of either sex desired. Already the town is filling up with childless people to be operated upon. Incidentally cases of insenity are cured within 36 hours after a simple operation. Other diseases also disappear. Milford is a small town 150 miles west of Kansas City. Here Dr. Brinkley has performed more than 100 major operations, more than 300 minor operations, each one a success, cured more than 1,000 cases of influenza, cured one 'hopeless" case of sheeping sickness and has banished cancer in the few cases offered."

The thing, of course, was a preposterous canard. Brinkley is unknown to scientific medicine, and the entire publicity campaign savored strongly of commercialism and quackery. Emboldened, apparently, by the advertising he had received, Brinkley came to Chicago, altho he was not licensed to practice medicine in the State of Illinois. The Department of Registration and Education of Illinois was preparing to take action against Brinkley when the man left the state.

In September 1920, we received from the Secretary of the Kansas Medical Society a statement reading:

Dr. Brinkley was a member of the Bourbon County Medical Society in 1919, but because of his unethical actions, was not transferred when he moved to Milford, Geary County. Our records show that he is not a member now, nor has his name been reported as being in good standing in the Kansas Medical Society.

My Deer Doctors-

I have just had a talk with Col. Rd Fletcher, concerning the application for a license in California of Dr. Brinkley.

Mr. Flotcher feels very keenly the apparent slowness of the Board of Medical Exeminers in action on this matter.

I showed Mr. Fletcher your letter of August 15th, and also told him about the short telephone conversation I had with Dr. Moloney in reference to the pamphlet issued by Dr. Brinkley, which is against our law and would omise revocation of the license of anyone issuing such a pamphlet.

Mr. Fletcher states very plainly that is Dr. Brinkley should have a license, he does not care how quickly it is revoked if Dr. Brink-ley oversteps our rules and regulations.

The reason of Mr. Fletcher's activity in this matter is for other political reasons, which I think he has expressed to you. It is not a selfish interest on his part, but for the interest of San Diego County.

If there is any way to bring this thing about, I would appreciate it. I expect to send a copy of this letter to Mr. Fletcher.
