BLACK & BROWN LEADERS IN COLLUSION WITH IMMIGRATION SERVICE TO PREVENT PEOPLE FROM WORKING

The killing of two Mexican illegal aliens on July 16, 1970 in Los Angeles, Calif. is another tragedy which can be ascribed to the Immigration Service which is a branch of the U.S. Dept. of Justice. In a Newsletter dated July 25, 1967, entitled, "Immigration Service Is Responsible For Deaths Of 2 U.S. Border Patrolmen", I gave the details why the Service was responsible. This Newsletter will review the actions of the Immigration Service which set the stage for the deaths in 1967 and the present deaths. It will tell about the misery and unemployment caused by the Immigration Service and will show how many socalled leaders of the Blacks and Browns (Mexican-Americans) are in collusion with the Service by not revealing how the exploitation is done.

The Immigration Service contrary to U.S. Law is flooding the U.S. with Hexicans so that employers can have a big pool of cheap labor. This is done by giving visitors' passes which are good for 3 days to Mexicans who are not supposed to work while in the U.S. In practice, the Immigration Service does not keep a record when these Mexicans with passes enter or leave the U.S. Fractically all of them stay in the U.S. and go to work at very cheap wages. Another very large group of Mexicans just illegally cross into the United States and go to work at very cheap wages. The Forder Patrol, a subdivision of the Immigration Service, does a very poor job of catching all these illegally working Mexicans because of limitations imposed by Raymond Farrel, Chief of the Immigration Service who is in collusion with the employers.

For the past 5 years, I have put out various Newsletters on the unemployment, misery, deaths, and narcotic and marijuana smuggling caused by the Immigration Service not doing its duties properly. The reader is advised to go to any library and read in the August 1970 Reader's Digest, the article by Lester Velie entitled "Poverty At The Forder" to get a good summary how the Immigration Service causes unemployment and misery mainly in the Southwest of the United States.

About 4 years ago, I spoke to high officials of the Immigration Service at headquarters in Jashington D.C. telling them to start a campaign of spot announcements in newspapers and radio and television broadcasts, telling the people to notify the Immigration Service were aliens were illegally working. The Service refused to do this. Every other law enforcement agency wants the people to give information were the law is being violated BUT THE IMMIGRATION SERVICE REFUSES!!!

I have told the Immigration Service that to remedy the situation, it must propose to Congress that a law be passed that any U.S. employer caught with a Mexican illegally working for him should be warned the first time. The 2nd time, the employer is fined 1,000.00 for each alien illegally working for him. The 3rd time should result in the same 1,000.00 fine for each alien plus one year in jail. The Immigration Service refuses to do this.

The receiver of smuggled goods is guilty of a crime. The employer of "smuggled labor" should be made guilty of a crime. The Mexicans are no fools. When they find out they can not get work in the United States there will be no reason for them to enter for the employers will not employ them.

The Los Angeles Times in various articles gives the figures of 100,000 to 500,000 as to the number of Mexicans illegally working in California. The blacks in fatts which had its riots in 1965, still do not have work. They are being deceived by the socalled black I aders who make no public protests about the illegal Mexicans getting the jobs.

Teaching the blacks how to work or to read, is not going to give them work if mobs of illegal Mexicans are going to be in Los Angeles willing to work for very low wages!!

Is it not peculiar that these illegal aliens who come from the rural areas of Mexico and have 2-4 years schooling are able to get the jobs? Many of the socalled black leaders have high paying jobs to teach the unemployed blacks how to work, etc. If the illegals would be chased out, the blacks of latts would have work. But then the socalled black leaders would lose their high paying jobs because there would not be any unemployed blacks to teach.

The same situation exists amongst the Mexican-Americans of last Los Angeles. They get no jobs because of the illegal Mexicans. Their socialed leaders also have high priced paying jobs that would go out of existence if the illegal Mexicans were deported. You will never read of these leaders protesting what the Immigration Service is doing.

Seven police were looking to arrest Daniel Gorostiza who was accused of murder. He was supposed to be at 826 W. 7th St. Los Angeles. It was night about 9 p.m. and there were 6 Mexicans in an apartment there. The suspected murderer was not there but the police did not know that. Then the police announced themselves, the 6 Mexicans although they did not know English well, were afraid of the Immigration's Border Patrolmen. Beltran Sanchez and Guillermo Sanchez who were shot dead by the police, had told their landlady that day, "Me have to go for we are afraid of the Immigration people" (Los Angeles Times 7,707).

The Los Angeles Times identifies both of the dead men as being illegally in the U.S. It is silent about the other 4 hexicans but it is highly probable that they are illegals also. The L.A. Times of July 23, 1970 says that Guillermo Sanchez earned \$2.50 per hour. Just multiply this illegal alien by the tens of thousands who are in Los Angeles, and you will then realize why so many blacks and browns are unemployed in Los Angeles.

The details of the shootings are unknown to me. But Border Patrolmen and Police do not shoot illegal aliens just because they are illegals.
