

As you may know, I have submitted my resignation as Executive Director of the Chicano Federation, effective June 14, 1972. Job announcements have been distributed among the various Chicano organizations throughout San Diego County announcing positions for Executive Director, Associate Director, and Executive Secretary. These two additional positions are new. I encourage each and every one of you to assist the Chicano Federation in recruiting the finest possible candidates for these important positions. The application deadline is June 9, 1972.

As you know, the Chicano Federation has grown in size and scope tremendously. The number of full-time staff has increased from three employees to some 32 in less than one year. In addition, the Federation has the responsibility of monitoring and evaluating some 38 P.E.P. employees, who are working directly for some of our affiliated Chicano organizations. Further, the development of program components in Education, Social Services, Economic Development and Fine Arts has progressed greatly. In fact, the Chicano Federation is responsible for a program which approaches \$1,000,000.

The success of the Chicano Federation cannot and should not be measured by the size of its staff — although increased jobs within the Federation are important to Chicanos seeking full involvement in the movement, and greatly increased size impresses Anglos. Rather, the success should be measured by the amount of institutional change the Federation has accomplished. In this regard, let me cite what I feel are major accomplishments:

1. Affirmative Action - The City and County of San Diego now have affirmative action programs. This means that more Chicanos will find meaningful employment in public service. In addition, it will be easier for Chicano organizations to advocate and get similar affirmative action plans from other major institutions - public and private.

2. Public Employment Program (PEP) - The City and County of San Diego, and the Office of Economic Opportunity of the State of California have allocated some 63 PEP employees to Chicano organizations, through the Chicano Federation process. At this point, the Chicano Federation is one of four organizations that have developed a joint relationship with local government to implement a creative resourcesharing approach to PEP. The implications of this arrangement are twofold:

a. Chicano Federation, as a community-based organization, is the recognized agency to prioritize needs in the Chicano community of San Diego County.

b. The possibility for Chicano Federation to allocate funds from local government sources, when revenue sharing becomes a reality, is imminent.

3. Mass Media Advocacy - The agreements reached between television stations KFMB-8, KOGO-10 and the Chicano Federation regarding better-image exposure of the Chicano perspective represent a national turning point in the mass media. The Chicano Federation, with a minimum amount of resources, took on two giants of the industry, Time-Life and McGraw-Hill, and prevailed. Chicanos throughout Aztlan should be justly proud.

4. Community-based Social Services -The Chicano Federation is developing a new concept in social services to Chicanos through the cooperation of the County of San Diego. This concept is aimed at resolving Chicano families' problems through a team approach - welfare, probation, legal, housing, immigration, etc. The team is housed in the barrio where Chicanos can readily reach it. The County of San Diego is now planning to develop similar decentralized social services throughout the county based on this concept.

Although the Chicano Federation has accomplished these successes and others, particularly in the area at education, much remains to be developed:

1. Political Power - The Chicano Federation needs to encourage the development of political awareness among our people. This can and should be done by encouraging the further development of political groups, notably the emerging "La Raza Unida Party," "Spanish Speaking Political Association," "Mexican-American Political Association," and others - such as, the Office of Ethnic Affairs - "Leadership Development Conference";

2. Law and Justice - Lack of equitable police policies and procedures for Chicanos still plague our people. Recent events have confirmed this to be one of our major problem areas. It is major because no matter what the Chicano Federation can do after the fact, in many of these cases, Chicano's life is lost, a family bereaved, community tension increased, and a police department insensitized. The Federation needs to develop more resources in order to attack this highly sensitive problem area.

3. Economic Development - The economic envelopment of "las colonias" by the larger Anglo economic structure needs to be "unveloped" and then developed under Chicano tutelage. The Chicano Federation should now develop a full-blown economic development program to decolonize our barrios and economically liberate our people. This should be possible, if the Chicano Federation puts out the welcome mat to all interested Chicanos to participate in a planning process for economic, busi-

ness, and financial development of the Chicano community. The tremendous potential for Chicano-controlled economic clout should no longer be deferred to the Anglo.

These are some of the ideas I would leave with the Chicano Federation. I am convinced that all are probable if we dare to think big and be unafraid of possible failure.

In parting, I wish to thank all of you for having supported me in this position. I consider it a rare privilege to have served as the chief staff person of the Chicano Federation. I shall treasure it always.

I wish all the luck to my successor. That individual will need the fullest support and commitment from all of us.

LETTERS TO EDITOR

Editor:

In consequence of hearings conducted 29 April, on the San Ysidro border incidents, by your committee, and per your verbal requests, I am submitting the recommended immediate legal safeguards required for the protection of our peoples (La Raza) civil rights.

I am well aware of the difficulty that exists in curbing, here to fore, unrestrained police powers of a federal agency, however, the limits of toleration has been reached. We, as Chicanos, can no longer tolerate the blantant raciest actions of certain elements of our federal government. Therefore, it is in the fervent desire for change that these, and other recommendations have been made.

If we are to survive as a nation united in common cause, then, perhaps it is the duty of those most oppressed to commence and continue the purging of the decayed and perverse members of a rotten society, a cleansing of our national consciousness so to speak.

The following minimun requirements, for protection of our people, compraise the main requests which I, speaking in behest of the SSPA, presented in summation at your hearings.

- 1. No person(s) shall be subjected to un-reasonable search without first being placed under arrest and charged.
 - a. This will help eliminate current "fishing" expeditions being conducted daily at the border.
- 2. No person shall be arrested until the officer making the arrest has "reasonable" grounds for doing so.
 - a. This will force the agents to use some other criteria other than "race" for establishing reasonable grounds.
- 3. A prepared statement, in Spanish and English, shall immediately be read to the person(s) placed under arrest informing them of their constitutional rights (right to remain silent, to legal representation, to make a phone call etc.)

- 4. A waiver of rights must be requested whenever a search is to be conducted without a search warrent.
 - a. If no waiver is granted, a search warrent must be procured.
- 5. The individual(s), thus arrested, must have a legal right for "redress" against the government for false arrest and searches whenever occuring.
 - a. This will cause a cessation of indiscriminate aressts and searches.
- 6 Legal representation must be afforded to all regardless of economic means at the evident in the corrected version
- port of entry.
 - a. The concept of a Ombudsman would be functional here.
- 7. That the F.B.I. procedures be utilized as a model for all police-power agencies of the Federal government in execution of their police duties.

As you may well recognize, these are very limited and minimum objectives, however, they are required immediately in order that relief may be afforded our people, however, it is recognized that fundemental change is required before the situation is corrected or eliminated.

As you well may be aware a considerable body of administrative regulation affects the Mexican and the Mexican-American (Chicano). Most of this administrative regulation has been the creation of agencies of the Treasury and Justice Departments. The sad story, however, is that their agencies have not, in many cases, observed their own regulations or the ordinary civil rights of citzens and alliens affected. I would conclude this letter be calling your attention that due process of law, under the 5th Amendment of our Constitution, is guaranteed not just to citizens and nationals of the United States but also resident aliens (Supreme Court decision of 1886). Due process, therefore, is our right and is not at the whim of the Customs bureau or the Immigration department, or the Border Patrol, to name a few.

Your continued interest in this matter is of vital concern to us all, and we shall look forward to concrete results from the Roybal hearings.

On May 3, 1972, a demonstration was held by Chicanos to protest some racist and administrative injustices done to Chicanos. The demonstration erupted into a large disturbance and S.D.P.D. was called onto the campus. As usual the media has mainly provided a one-sided biased view of the incident. There were many things which led up to the May 3rd demonstration, which could be summed up thus: San Diego State University is a racist campus - this is a reality.

Past incidents have proven this. On May 23, 1970 an incident occurred which almost triggered off a similar incident. The school newspaper ran an article stereotyping blacks and Chicanos. It showed blacks with spears and bones in their noses making them look like savages, and Chicanos yelling, sleeping and with bottles of booze, supposedly depicting them as loud, lazy, drunken Mexicans.

Since then Chicanos have tried every possible way, legal channels and working with the administration to sensitize and make them aware of the problems facing Chicanos in the educational system, Note that in 1968 there were only 75 Spanishsurnamed students attending S.D. State. Now in 1972, there are 1,075 students on E.O.P (Educational Opportunity Program). This campus has seen this as a threat. It seems to have a lot of Chicanos coming to the college. We have tried working with the students by running for student council positions and again ran into a racist block. Obstacles were thrown in our way, such as losing our applications, misplacing our examination packets, giving us a lot of runaround, etc., (only to Chicanos did this happen, though). This happened during the first election. In the second election we ran two Chicanas and four Chicanos for office -- again the same racist block, mainly by the school paper again. The paper, which is paid for by all the students on the campus, endorsed and encouraged its slate of candidates, which were mostly conservative anti-Chicano, and against E.O.P. They received considerable publicity, while the Chicanos who were running received nothing but racist slurs, slander, and remarks and were called "Special interest groups," militants, etc. After this happened students picked up the newspapers the next day and burned them in protest. Still the school paper continued to write racist articles Continued on page 5

SCHOOLS FAIL MINORITIES

Excerpt from San Diego Union Washington (UPI)

All five Southwestern states examined by the U.S. Commission on Civil Rights "are failing" to give adequate education to black, Mexican-American and Indian students, the commission said today.

Minority group students in the Southwest show appreciably poorer records than Anglo students. Mexican-Americans, blacks and Indians are the potential dropouts, the semiliterate, the unqualified who. if unable to become an affirmative part of our society, may become a burden to it," the commission said.

The conclusions were in a report entitled "the unfinished education," and dealing with education in Texas, California, Colorado, New Mexico and Arizona.

Of the five states, Texas had the lowest overall ranking in its education of minorities, the report said.

"Nearly one half of (Texas) Mexican-American pupils leave school before completing the 12th grade. Black children also fare badly in Texas. An estimated 34% of the black students leave between the eighth and 12th grades," the report said.

"In California, Mexican-Americans are 2.5 times more likely than Anglos to leave schools before high school graduation, while blacks are 2.3 times as likely not to graduate. As for Colorado, New Mexico, and Arizona, Anglos still have the lowest rate of loss," the report said.

The commission checked 532 school districts and 1,166 individual schools for reading ability, students who repeat grades, what ages are in school, the dropout rate and students' participation in extracurricular activities.

The commission said it found in the Southwest are:

-By the eighth grade, 9% of Mexican-Americans have left school and by graduation time, 40%.

-About 67 blacks of every 100 remain to graduate, about the same percentage shown by Indians.

-Of each 100 Mexican-Americans in school, perhaps 5 will graduate from college.

-Mexican-Americans are 3 times as likely to repeat first grade as are Anglos and almost twice as likely as blacks.

-More than half the Mexican-Americans and blacks in grades 4, 8, and 12 read below the level of their grade.

Schools' Cheat' U.S. Mexicans

Schools in the U.S. Southwest are shortchanging more than a million Mexican-American students who depend on them for an education, the U.S. Commission on Civil Rights said here yesterday.

The Mexican-American child's problems start early, it said. Nearly half the Mexican-American first-graders in the five states do not speak English as well as their Anglo classmates, the report says.

Although fewer than one-fifth of California schools do so, the report estimates about one-third of the 5,800 schools in the Southwest discourage the use of Spanish in the classroom. Some schools even punish children for speaking Spanish on the playground, according to the commission.

In essence, they compel the child to learn a new language and at the same time to learn course material in the new language," the commission says. "This is something any adult might find unusually challenging."

By the fourth grade, 51 percent of the Chicano students are six months behind their peers in reading ability and 17 percent are two or more years behind. By the eighth grade, 64 percent are six months behind.

Even the 60 percent of Chicano students who make it to the 12th grade still are having reading problems, with 63 percent still six months behind and 24 percent still reading at the ninth grade level or below.

BEST SOLUTION

Of the solutions now being offered the Mexican-American student, the commission says the best is "bilingual education" that offers instruction both in English and Spanish and includes insturction in both cultures. California, which had the federally-funded bilingual programs in 85 percent of its schools in 1969 and thus led the other five states, reached only 1.7 percent of its Chicano students, however.

Schools in and around San Diego do more than most of their counterparts in the Southwest to help Mexican-American students over their language barriers, but many school officials agree they need to do still more.

According to a report released yesterday by the U.S. Commission on Civil Rights, schools in California, Arizona, Colorado, New Mexico and Texas do a poor job of educating Mexican-American students.

In San Diego, more than 1,600 of the city's 13,500 Mexican-American students attend classes aimed at improving their English.

Clifford Mendoza, who holds the city school district's newly created position of curriculum specialist in bilingual education, said 30 teachers and 15 aides teach ESL (English as a second language) classes for 1,040 children in 22 of the city's elementary schools.

"We have no subject matter taught in

Ralph Skilles, the district's assistant superintendent for instructional services, estimates about 1,000 of them are in 34 ESL and 50 bilingual classes.

Most of those classes are in Southwest Junior High and Montgomery High School, the two secondary "target" schools of a \$407,000 federally-funded bilingual project that includes three elementary districts as well.

Now in its third year, the project is headed by Paul Juarez and extends into Kimball Elementary in National City, Montgomery Elementary in Chula Vista and Nestor Elementary in the South Bay Union District.

At Nestor, the oldest of the programs, 96 youngsters from kindergarten through the third grade learn under a completely bilingual system. The other two elementary schools involved extend only into the second grade.

Juarez, whose staff is busily designing more class materials, says the plan is to add another grade each year until the bilingual programs extend through all grade levels.

In Chula Vista, where 20 percent of the city's 17,000 elementary youngsters are Mexican-American, about 950 youngsters get a half-hour's instruction a day in ESL.

But those pupils are only the ones with "practically no English," says Mrs. Mary Crawford, the district's ESL specialist.

In National City, 326 elementary students who have "the most trouble with English" get ESL instruction for up to an hour a day, according to Dr. John Otis, Curriculum Coordinator.

Some 36 percent of the district's 4,500 pupils are Mexican-American.

The South Bay Union Elementary District in Imperial Beach has a total enrollment of 6,000, of which 17 percent are Chicano.

Dr. A. W. Autio, assistant superintendent, estimates 200 of the ones who are "truly nonfunctional in English" get ESL instruction.

In the San Ysidro Elementary District, nearly all students get ESL instruction, says Robert Coleman, director of instruction.

That district's 2,100 students, crowded into three schools, are 75 percent Mexican-American, Coleman said.

The district has seven "transitional" classrooms for youngsters with no English at all.

Coleman said the \$570,000 the district gets from the federal government is what keeps it from floundering under the language burdens of its students.

NEW BILINGUAL PROGRAM

A three-year program for English-and Spanish-speaking pupils will be initiated at the kindergarten level beginning in September in three selected San Diego City schools.

The program, to be financed by \$212,000 in state funds over three years, will involve 90 youngsters whose dominant language is Spanish and 90 youngsters who speak English only.

The purpose of the program is to teach mathematics, science, and social sciences in the children's native and second languages. At the same time these two linguistic groups will receive instruction in English as a Second Language (ESL) and Spanish as a Second Language (SSL) respectively.

Impact on the Spanish-speaking children's self-concept will be determined at the end of the program.

The plan for implementation calls for dividing the 180 children into six equal classes, with an equal number of Spanish-speaking and English-speaking children in each class.

Classes will be staffed by bilingual kindergarten teachers and instructional aides.

The San Diego Unified School District is one of two school districts in the state to receive funds made available through Assembly Bill 116. The other district is San Francisco where the program will involve Chinese-speaking youngsters.

"The schools use a variety of exclusionary practices which deny the Chicano students the use of his language, a pride in his heritage and the support of his community," the commission said in an 86-page report.

The report, the result of a study of schools in California, Arizona, Colorado, New Mexico and Texas, was released by Commissioner Manuel Ruiz of Los Angeles during a press conference yesterday.

The commission surveyed practices in 532 school districts in those states with enrollments of more than 10 percent Mexican-American during the spring of 1969. It reports 40 percent of those students drop out before graduation and links their dropout rate to school practices that ask them to turn their backs on the culture and language of their fathers.

Spanish at the elementary level," Mendoza said. "What we have is a minimal maintenance program and the students have to struggle around the rest of the day in English after 20 minutes or so of ESL instruction."

San Diego High School, for instance, has 200 of its 570 Mexican-American students in courses that combine instruction in English with math, history and science classes taught in Spanish.

Memorial Junior High has a similar program for 160 of its 615 Mexican-American students but the 197 at Montgomery Junior High are offered only two ESL courses which 15 are now taking.

The Sweetwater Union High School district in the South Bay has 21,000 students of which about one-fourth are Mexican-American.

about Chicanos. This main issue built up the anger, frustration and disgust of Chicanos, when added to the cut-off funding of E.O.P. by Governor Reagan, which would have put all 1,075 E.O.P students who are under financial assistance by Chicano E.O.P. out of school and somewhere in the streets. There are over 27,000 students at S.D.S.U. Roughly about 1,200 are Chicano students. These are just a few of the many issues that have faced Chicanos since they started coming to S.D. State. Some talk about the destruction and violence that hit the Administration Building, which is a racist institution of a racist society. But little is said of the violent destruction that this insensitive educational system does to our peoples' heads - our human mind, the destruction of our history, our culture and language, which goes on every day in the lives of Chicanos in the Barrio, education system, prisons and military all run and controlled by this racist society that we live in. An example of the racism that has been around a long time: Chicanos and Indians were the first people here in America and San Diego. San Diego State was built in 1897. Of the total population of students, there were no Chicanos or Indians attending. Only within the last few years were minorities given the opportunity to attend college. This only to get confronted in racist manners and acts. If these schools, colleges and universities are meant for all the people, why weren't we allowed in them in 1897? And even now, aren't our Raza considered people? Human beings also?

Note: MECHA — The on-campus Chicano organization, has meetings every Tuesday evening. Attend a couple; not only at San Diego State, but all the other colleges, and see for yourself what Chicanos are up against in the schools, colleges and universities.

Chicano Federation enters into record setting agreement with McGraw-Hill

The Chicano Federation and the members of the Five-City alliance have reached an accordance with McGraw-Hill. As a result, McGraw-Hill will embark on a program of affirmative action in their programming, employment and all the stations' operation.

Under the agreement reached, McGraw-Hill has promised that it will acquire only two of the three top-fifty market Time-Life stations plus one in Bakersfield and San Diego. In return, the Chicano petitioners are dismissing their court appeal.

In the areas of programming and operation, McGraw-Hill has agreed to the following:

- The purchase of only four stations, two of these in the top-fifty market.
- Production of 18 La Raza Programs.
- Each station will produce twelve prime time cultural shows and twelve prime time documentaries on minority accomplishments.
- Each station will program a weekly, halfhour prime time public affairs show. At least one a month will deal with minorities.
- Three of the stations (excluding Bakersfield) will produce three other weekly public affairs show. Thirty percent of these will deal with minorities.
- National coordinator to implement McGraw-Hill's minority concern program.
- Public Access, Public Service Announcements. Each station will make time available for the presentation of public access PSAs by local persons in the com-

Una senora en National City hace esta pregunta tocante su madre:

- Pregunta: Mi madre esta afiliada al Medicare y pronto soldra del hospital despues de una enfermeda prolongada. Si yo empleo a una vecina para que venga a mi hogar y la cuide, ayudara el Medicare con esto gasto?
- Respuesta: No. Esta clase de servicio no esta cubierto por el Medicare. Bajo ciertas circumstancias, el Medicare puede pagar por algunos servicios de salud tales como cuidado de enfermeria profesional, y terapia física o del habla. Pero estos servicios deben ser suministrados por una agencia de servicios de salud en el hogar participante, bajo un plan establecido y periodicament revisado por un medico.

Answer: No. This type of service is not covered by Medicare. Under certain conditions, Medicare can pay for such home health services as part-time skilled nursing care and physical, and speech therapy. But these services must be furnished by a participating Home Health Agency under a plan established and periodically reviewed by a physician.

Question: I recently moved here and I noticed my Social Security number is a lot different from the numbers of my coworkers at the office. Should I get a new number in this area?

Answer: No. Your Social Security number never changes. You should use the same number all your life, no matter where you live.

A man in Paradise Hills has this problem:

- **Question:** I will retire next year. When I was looking over my birth certificate, I found that it does not show my first name. What should I do?
- Answer: You should take the certificate to any Social Security office and discuss the problem. The Social Security representative may be able to assist you in confirming that the certificate pertains to you.

The Chicano Federation and Committee in Chicano Rights hosted a reception for Lionel Castillo, commissioner of the Immigration and Naturalization Service on May 19, at the Chicano Federation.

CARLIN CASE

Chicano students were well represented by parents at a school integration meeting held at San Diego High School last week, reported Leonard Fierro, chairperson of the Chicano Federation Education Committee.

Eleven meetings were held last week with the Commission on School Integration, said Fierro.

Chicano parents gave a lot of input in the meeting and criticized Judge Walsh's ruling on the Carlin Case which declared 23 black and brown schools racially isolated.

The parents questioned the fact that Judge Walsh did not say anything about "all white schools" which parents claim are racially segregated too. They also complained about the lack of communication in Spanish within the district.

According to Fierro, the Chicano parents are against any force bussing of their children. If in any case there must be bussing, the parents siad it must work both ways with the other children.

The parents also supported the Chicano Federation's position on school integration.



County Lawsuit:

A federal judge has entered a consent decree on behalf of the Chicano Federation involving an employment discrimination lawsuit against the County of San Diego.

Judge Edward J. Schwartz signed the consent decree May 6, 1977.

"The consent decree entered in this case settles serious long ignored problems of discrimination against Chicanos and other minorities in the employment of county government," said Frank Cronin, attorney for the Chicano Federation.

"Since the Chicano Federation was the first organization to take action against the County, by filing charges with the federal government in 1973, we were allowed to intervene in the suit so that our views on the long-range solution could be heard," he said. "The Federation will continue to monitor the County's progress towards creating a discrimination-free environment for all it's workers."

The major thrust of the decree is to provide prospective relief for minorities by establishing hiring and promotional goals in all job categories which Chicanos have been underutilized in the past.

The final measure of success will be when Chicanos reach the point where they hold jobs in county government in the ratio that they represent in the civilian labor force of San Diego County.

Two important qualifications concerning the issue must be emphasized. First, it does not require the County to lower any employment standards to allow minorities and women to be hired or promoted. Everyone must compete on the same basis, accordance with fair and job-related standards.

By December 1976, Ethnic Studies and other departments were notified by the University College that most of their courses had been rejected. When the Faculty Senate met in February, they agreed with the University College decision.

As the controversy continues, the decision has been made. Still, no one knows what the repercussions of the University College and Faculty Senate may be, but the effects may be widely felt. This decision could affect the future of Ethnic Studies (such as Chicano. Black, Indian and Asian courses) at SDSU, the community colleges and transfer student requirements, student registration, and even faculty allocations.

The hardest hit may be the students themselves, whose options will be limited in fulfilling required courses and whose concept of general education is given a narrower view.



Federation's Position On Integration

The Chicano Federation Board of Directors met in a joint session with the Federation's Education Committee on May 9, to formalize and adopt the C/F's position on Integration of San Diego Unified School District.



NOT A PRIVILEGE

Rafael Fernandez, Chairperson of the Board issued the following statments:

- 1. We are for quality education for our Children.
- We are in favor of voluntary bussing efforts.
- 3. We are opposed to bussing that involves only minority children.
- We are for maintaining and expanding bilingual/bicultural programs that meet the specific needs of our children.
- 5. We are for keeping the student needing bilingual programs in their neighborhood school environment.
- 6. We are in accordance with the intent of laws that affect education in as much as they give priority to the protection of our children's programs.
- We are in favor of an effective district-wide mandatory cultural awareness in-service training program to accompany any bussing effort.
- 8. We are opposed to the transfer of any teacher, for integration purposes, that is engaged in programs that meet the needs of minority youngsters.
- 9. In order to comply with the districts' Affirmative Action plan, we are in favor of increased hiring and promotion of Chicanos.
- 10. All of the educational reforms proposed above must be implemented and are not to be construed as being contingent of the establishment of an intergration plan.

THOUSANDS CELEBRATE CHICANO PARK'S 7th ANNIVERSARY

The brown Mestizo flag de Aztlan was raised with pride during the 7th Anniversary of Chicano Park Day.

It was seven years ago, April 22, TERRAO 1970, when the community marched onto that small piece of land under the Coronado Bay Bridge and began to build their own Chicano Park.



Barrio residents were angered over the City Council's decision to use the land for a Highway Patrol sub-station.

But now, the take-over of the park is written in Chicano history as one of the major political events of the decade and victory for La Raza. Chicanos had mobilized themselves in a united effort for community control and self determination.

This year a new chapter was created in Chicano Park history when "Chunky" Sanchez officiated an afternoon wedding ceremony. But in this wedding, one didn't see any fancy dresses, tuxedos or hear any church bells. This was a Chicano boda. Three Chicano couples married by a Chicano, and while a large throng of brown faces looked on, history was recording itself in Chicano Park. A wedding ceremony that perhaps, will never be performed by any minister, judge or priest. Chicano Park Day, 1977, will be remembered by Eri Oriol and Lupe Parong and four senior citizens who decided to make this day their annversary too.

San Diego's finest bands kept the spirit and mood alive and the Chicano community welcomed special guest speaker Dorinda Moreno from San Francisco.

The cultural aspects of the day were hi-lighted by Los Concheros, (Aztec dancers) and Ballet Folklorico en Aztlan. There was plenty of food for those that had a hungry appetite and carnival games for the kids.

And while all of this was going on, the brown Mestizo flag waved proudly in the sky.





Judge Signs Consent Decree

<u>Second</u>, the goals for hiring and promotion will continue to be in effect until the County reaches parity with the civilian labor-force for each job category.

The Federation recognizes that while future improvement of opportunities for minorities and women is the primary objective, it is also important to provide some relief for those persons who also applied for jobs but were rejected for discriminatory reasons.

The decree provides two distinct mechanisms.

1-) The county will pay-back those minorities who came close to being selected but were rejected in favor of white males; the time limitation for those certified is Jan. 1, 1975.

This group will be offered one-time payments of \$350, plus priority job offers. If no jobs are available within two years, they will get an additional \$100.

2-) The second group of persons eligible for relief are those whom the County found eligible for jobs since Jan. 1, 1975, but did not score high enough to be certified for jobs. This group will also be offered priority placement in jobs.

All other minorities and women who were rejected in the past will be allowed to re-apply for jobs.

The last vital feature of this decree is that it provides a method by which the Federation can moni-The Federation is guaranteed full participation in the periodic reparticipation in the periodic review. It will receive detailed progress reports and analysis of the County's activities. It has the right to confer deficiencies with the County and try to resolve the issue. If no agreement is possible, the Federation has the right to apply to the federal district court for an immediate ruling on the issue.

The Federation believes that it has played an important role in improving the quality of the decree through active participation in negotiations. Most important, the Federation has established that it has a continuing and direct interest in representing the Chicanos in San Diego County.

Following the signing of the consent decree by Judge Schwartz, Jessie Ramirez, executive director of the Federation spoke to the news media during a press conference at the County Building.

"We look forward working with this document, The consent decree isn't perfect and doesn't solve all the problems," said Ramirez. "But Federation recognizes that it is a changing organization. The decree provides the Federation to be part of the solution."

"We will work with the county to improve affirmative action programs and will be involved into finding discrimination practices in local, state and federal levels," he said.

Ramirez thanked the Mexican-American Legal Foundation for their support.

REVERSE THE BAKKE DECISION

It is imperative that the Chicano Community realize the effects the BAKKE DECISION will have on our people's education.

Who is Bakke? Allan Bakke is a 36 year-old white civil engineer, who filed a complaint and claimed he was denied admission to the medical school at U.C. Davis for two consecutive years, because special admission programs gave preferential treatment to ethnic minorities.

On Sept. 16, 1976, the Calfiornia Supreme Court ruled in favor of Bakke claiming he was a victim of reverse discrimination.

The case is being reviewed by the United States Supreme Court. If the Bakke Decision is upheld, it could mean an end to affirmative action programs and even the Educational Opportunity Program (EOP), which minorities use to enter and finance their college education.

Many Chicanos have profit from the so-called special admission programs and services of EOP. These programs have helped Chicanos obtain college degrees. But this will be destroyed if we do not act now. The greatest implications will fall on the high students because they may not attend college if the Bakke Decision isn't reversed.

These programs were not a gift handed down to us. They were the result of struggles and demonstrations by many Chicanos. These opportunities were made so that a decent education could be given to those who have been deprived of one. MECHA Central of San Diego County is asking the community to join the fight against this racist decision that must be reversed.

Ethnic Studies Rejected

Students at San Diego State University are attempting to reverse a Faculty Senate decision which eliminates Ethnic Studies courses from the 1977-78 Foundations of Learning section of the General Education requirements.

The change in G.E. requirements will eventually affect community colleges in the county because students will stop taking Chicano, Black Studies, etc., since they will not meet SDSU's requirements. A drop in enrollment will mean the firing of many ethnic studies instructors and the elimination of ethnic studies departments.

The issue of the exclusion of many G.E. requirements came to light early in the fall of 1976 when the University College, an administrative arm of the Vice president's office, asked departments to submit courses that could be considered for inclusion in the new G.E. requirements.

HEW (Health Education & Welfare) annuncio el dia 21 de Abril pasado, que un aumento de 5.9 pro ciento sera adjudicado a los recipientes de cheques de Seguro Social (Social Security) y SSI (Supplemental Security Income).

CALIFORNIA ESTABIECE UN CONGRESO QUE

ENCOMPASA EL ESTADO

Un movimiento para establecer una organizacion que encompase el Estado se ha iniciado en California con la creacion de un Comite titulado "Congreso de Señores Mayores de California". El Comite se organizo en una junta de 50 organizaciones representantes de mayores de edad, que se llevo a cabo en Enero de 1977 en Sacramento. Aprobo tambien los objetivos y principios similares a los de la "National Council of Senior Citizens" Concilio Nacional de Ciudadanos Mayores.

Al presente los planes tienen por objeto mantener una ofician Intercesora como una base focal para los esfuerzos legislativos del Congreso en conjuncion con participantes grupos y Concilios del Area.

Cuarto semejantes Concilios se han establecido en Los Angeles, Fresno, Modesto y Monterey y otros estan pendientes.

El Congreso de acuerdo con el Primer Vice-Presidente James CArbray del National Council of Senior Citizens, "tiene el intento de proveer el sistema para coordinar esfuerzos de miles de Club de Senores Mayores en California y asi dar fin a la fragmentacion que ha conducido al vencimiento de muchos esfuerzos legislativos en favor del mayor de edad y el pobre.



Este aumento a los cheques de Seguro Social seran pagados aproximadamento 150,600 beneficiarios de 60 anos de edad o mayores, del condado de San Diego. Las nuevas cantidades tomaran efecto el mes de Junio, y estaran incluidas en los cheques del mes de Julio, que se recibaran el dia primero de idcho mes; (debido a que el dia e del mes caera en Domingo, los cheques seran recibidos el dia l de Julio).

El 5.9% significara un aumento total de \$2,269,584 para los benefciciarios del Seguro Social (Social Security) del Condado de San Diego, elevando esto a un gran total de \$43,184,070. El setenta y seis por ciento (76%) o \$33 milliones seran para los de mayor edad (Seniors) cada mes.

El promedio de beneficios para un trabajador jubilado sera aumentado de \$221.00 a \$234.00 por mes. Los beneficios para un matrimonio aumentaran de \$337 a \$400 por mes, mientras que los beneficios para las viudas y viudos subiran de \$210 a \$223 por mes.

Los beneficios maximos para un trabajador jubilado en 1977 a la edad de 65 anos ascendera de \$412 a 437.10. Beneficios minimos a los 65 anos subiran de \$107.90 a \$114.30.

Aproximadamente 36,000 beneficiarios de SSI del condado de San Diego, recibiran tambien el aumento de 5.9% en sus cheques el dia 1 de Julio. Las cantidades oficiales todavia no se han publicado pero el aumento para una persona que vive independiente sola, debera ser \$286 por mes, del nivel actual de \$276.00. Para una pareja, subira de \$552 a \$536.00.



Dear Mr. Blankfort,

I have recently finished reading and re-reading the article by Linda Cross about Herman Baca which appeared in your newspaper, Thursday, July 24, 1977. Reducing it down to its basic elements, this article is the epitomy of yellow journalism, personal vindictiveness, professional jealousy, racism and hicktown provicialism: Further it is repleted with platitudes; contradictions and errors. It has been a long time since I have written to you; since my last letter to you was altered to protect a public figure. I do so now because I am compelled to react to the viciousness of the personal attack on Mr. Herman Baca by Linda Cross. I wish to respond to certain points in the article which I feel should not remain unanswered.

Since I am a resident of National City, Mr. Baca has spoken for me and many others, he has never taken a public position without first calling a community meeting to inform the community on issues and obtain direction from them on a particular matter.

On the subject of rezoning the west side, we attended almost every public meeting called by the Redevelopment Agency, for that purpose. Many residents along with Mr. Baca spoke on the issues that were raised. The only reaction we had from the City Administration was to put it before the electorate of National City. Because of a very well organized Morgan controlled voting block and again very biased reporting by your newspaper, the proposal to rezone the west side was defeated. On the question of Mr. Tato Rivera's murder; Mr. Baca along with others took a very potentially dangerous situation and created a manner by which an angered community could express frustration in a nonviolent manner, he did this at a time when city officials did nothing to alleviate this situation; indeed, Mr. Baca and his group did much to counter provocative efforts and statements made by the mayor and members of the city council and other city officials.

The racist attitudes of Sweetwater High School officials are seen throughout the community. The deficiencies in bilingual education; teacher sensitivity, and in the utilization of existing resources have been lacking for many years. The Sweetwater Union School District has done very little to correct these deficiencies on its own.

Mr. Baca is indeed a change agent. Through his and other's efforts, some changes for the benefit of the community have come about. Changes beneficial to the Spanish Speaking community will not come about because of the kindness of school or public official's heart's. These changes, limited, have come about because of pressure from groups such as those represented by Mr. Baca. Continued from page 2.

I see Linda Cross' article as a reprisal against Mr. Baca because she could not mold him into the image that she had created for him. The audacity of Linda Cross' assumption is that the South Bay is her exclusive journalistic domain and that all others, out of towners, are somehow trespassers; it is vindictive and a sophomoric view of the world of journalism, and somehow transcends the concept of constitutional guarantees of a free press. Ms. Cross apparently is still wearing her hicktown blinders which prevent her from seeing that San Diego is to the east and south of National City as well as to the north. Further, that a source of news is a source of news, whether it be in National City or in any part of the county. As for the "Circus", Mr. Baca staged, I can't see how Ms. Cross could project herself as a casual, detached observer, since she was the only one who begged Mr. Baca for permission to be there, while the rest were invited. I can see now, where her insistence on being there, was primarily for the purpose of having a platform on which to launch her attack on Mr. Baca and others.

We have indeed, turned to the television and radio stations, and to the San Diego newspapers in our efforts to present our point of view to the public. After years of experience with your biased and prejudicial reporting as well as your personal vindictiveness against Mr. Baca, myself and others who had given up on your newspaper.

The last vicious aspect of Linda Cross' letter is of course that segment that deals with alleged "Fear of Reprisal" on the part of some "Mexican-Americans." This kind of implied action is a new low in journalism, even for the Star News. One of the hallmarks of Mr. Baca's efforts and to which I personally adhere, is the principle of non-violence and a commitment to work within the framework of the law.

Indeed it has been Mr. Baca and his supporters who have been the target of reprisal and violence. Mr. Baca's home has been shot at; his business as well as his home have been the targets of bomb threats. His family and his friends have been the butt of threatening, intimidating and obscene phone calls. Deputy Registrar of Voters have been harassed by police officers and his efforts have been purposely snarled in bureacratic red tape by "Duly Elected Public Officials."

Change <u>will</u> take place in the South Bay in the fields of education, political representation, delivery of public services and in the delivery of news to the South Bay residents, in spite of the Linda Crosses and Lowell Blankforts

This letter is for you, Mr. Blankfort, <u>personally</u>, you may print it if you wish but only in its entirety and without alteration.

Nosotros como representantes del Comite sobre los Derechos Chicanos, y la Federacion Chicana, expresamos nuestra opinion de que la solucion ofrecida por el Presidente Carter, llamado "Solucion comprensiva de los Extranjeros" es en su mayor parte inhumana, privada de realismo, e'imposible de ejecutarla y ponerla en vigor. Opinamos que el Presidente Carter, por esta accion está creando un incontrolable "monstruo Frankenstein" con su desesperada tentativa de reponder a la histeria de las masas, creadas por el Comisionado anterior y ciertos otros grupos investidos.

Creemos que lo que propone el Presidente Carter es solo una tentativa muy debil lanzada en la oscuridad para una solucion, porque hasta la fecha no hay evidencia impugnable sobre la cantidad de "extranjeros ilegales", el numero de empleos que se suponen son adquiridos por dichos "ilegales" privando de estos empleos a los ciudadanos de EE. UU., ni de la cantidad de dinero utilizado para los servicios sociales a los "extranjeros ilegales". La "amnestia" propuesta antes de 1970, en nuestra opinion, es realmente nada mas que una "farsa" por las siguientes razones:

 Hay una ley existente que especifica que un extranjero con siete anos de residencia continua, y la equidad correspondiente, puede solicitar su clasificacion como "residente legal permanente".

2) El Estudio Lytton de 1976 comprobo que muy pocas de las personas aprehendidas por el Servicio de Inmigracion habian estado en el país mas de dos años. Asi es que el llamado "programa de amnestia" afectaria solamente a un pequeño percentaje de trabajadores sin documentacion ("ilegales").

- 3.) La burocracia insolvente "Servicio de Inmigracion y Naturalizacion" (INS) tinne una cola de espera a quien servir, debido a su incompetencia, y su actitud racista. No hay razon para creer de que el Servicio de Inmigracion y Naturalizacion (INS) pueda cargar con este trabajo adicional, que la proposicion causaria.
- 4.) Debido a las razones mencionadas mas arriba, creemos que el motivo real tras la "amnestia" es para seducir a los "ilegales" a presentarse para ser identificados, para ser sometidos a los procedimientos de deportacion mas tarde. Se Continura en pagina 8.

SWEETWATER DISTRICT LAWSUIT

A Coalition of Chicano and Black organizations will be filing a lawsuit against the Sweetwater Union High School District in either Federal or State Court.

The Coalition consists of the Committee on Chicano Rights, Inc., United California Mexican-American Political Association, N.I.A., Black Federation, Chicano Federation, Spanish Speaking Political Association, G.I. Forum, MECHA San Diego State University, Chicano Park Steering Committee, La Raza Lawyers Association, Pinto Union of San Diego, IMAGE, Chicano Democratic Caucus, CASA Justicia, and the Legal Aide Society of San Diego.

This action came about due to the recent meetings with school officials and Palmer Jackson, a representative from the Office of Civil Rights. The meetings stemmed from charges that the school district is failing to provide adequate educational opportunities for Black and Chicano students.

The present minority student population is quickly approaching 50% (12,109), yet the school district employs only 102 minority teachers out of 1,018.


The initial meeting with the District Superintendent Earl Denton proved fruitless in that by his own admission, "I had to deal with questions in the abstract and could not give concrete solutions."

During the meeting such things were discussed as desegregation, bilingual education, affirmative action, and the removal of a Cinco de Mayo display by Sweetwater High School Principal William Darton.

A meeting was also requested with Jackson when it was learned that the Office of Civil Rights would be investigating the school district. This meeting also proved fruitless as it was discovered the Civil Rights office would not be conducting a full-fledged investigation but rather an investigation to determine if the district is deliberately segregating students racially and ethnically. Jackson said he could not give out any information on concerning the investigation. Jackson's reply was "I'm not your investigator". He suggested to the coalition and organizations that they obtain information by way of the freedom of Information Act.

Among charges of failure to implement a workable affirmative action plan, violation of students consitutional rights including equal protection and due process, inadequate assessment process for identifying non or limited-English speaking national-origin minority students, the district is also accused of deliberately failing to apply for Emergency School Assistance Act Funds (ESAA) which provide bilingual and special counseling programs to assist students relocated as part of a desegregation effort.

This resulted in the loss of \$600,000 for the school district and consequently a better quality of education for minority students.

The live music by Los Alacranes brought the Senior Citizens to their feet and Mrs. Ouintero said they "loved the music."

Over-all, Mrs. Quintero said the event was a success and everyone seemed to enjoy themselves.

The Senior Citizens Center, located on 3278 Main St., Chula Vista provides many services to the elderly, according to Mrs. Quintero.

Besides the recreational activities such as ceramics, arts and crafts and bingo, the Center helps Seniors with counseling (family, marriage, financial problems), informational and referral services and legal assistance.

The Center holds English as a Second Language (ESL) classes and offers. interperters and translation services to them.


Mrs. Quintero says that Seniors from the Center visit other Seniors who stay in convalescent homes and hospitals.

La falsa promesa del programa de amnestia es cruel, pero la propuesta de establecer un estado (status) de "residente temporal" es todavia mas inhumano. El trabajador sin documentacion("ilegal") que entró a EE. UU. entre 1970 y 1976 será permitido rabajar, pagar sus impuestos, pero no se le permitirá que sus familiares mas cercanos se le unan, y despues de cinco años estará sujeto a los procedimientos de deportacion.

Esta proposicion no es mas que una legislacion para la servitud, que creará una clase social de "siervos" (untouchables) que estará obligada a pagar impuestos sin representacion.

La proposicion seria una violacion directa de la enmienda #14 que provee una garantia a toda persona en los EE. UU., igual proteccion bajo la ley. Esencialmente la proposicion viola a aquellos que quieren trabajar y premia a aquellos que no quieren.

Con referencia al aumento de 2,000 oficiales de patrulla para la frontera, es evidentemente lo mas definitivo, pero al mismo tiempo el segmento mas peligroso de la oferta o recomendacion de Carter. Esta recomendacion es una regresion de la Administracion de Carter a los "ejercicios de guerra" del General Chapman. En la superficie esto parecera ser un esfuerzo para detener la"corriente" de las entradas ilegales, pero en realidad nosotros lo vemos como una invasion de nuestra comunidad, que inevitablemente causara el aumento de violaciones de nuestros derechos humanos constitucionales. Tenemos la creencia, basada sobre origenes de buena tinta de que ya se han hecho planes para la reactivacion del gran "rodeo y deportacion" de la decada de los 1950, llamado "operation wetback" (campana contra ïlegales.)

En conclusion, nuestra organizacion propone las siguientes soluciones alternativas:

- 1.)Un programa de amnestia factible, con enfasis a la unificacion de las familias.
- 2.) Audiencias nacionales para formular una poliza justa inmigracion humanitaria.
- 3.) Una Orden Ejecutiva, suspendiendo todas las deportaciones hasta que el Congreso haya desarrollado, per mediacion de las Audiencias Publicas Nacionales, un sistema de inmigracion comprensiva y realistica.

(Nota del Editor: Esta carta fue enviada a Lowell Blankfort de "Star News" de Chula Vista. Hasta la fecha no hemos recibido contestacion algun, ni ha sido publicada en "Star news."

Querido Sr. Blankfort:

Recientemente he acabado de leer y "re-leer" el articul de Linda Cross sobre Herman Baca el cual se Publicó en su periodico el Jueves, Julio 24, 1977. Reduciéndolo a sus elementos mas básicos, éste articulo es epitomo del periodismo oblicuo, personalidades vengativas, celos profesionales, racismo y provincialismo de puebluchos; y ademas está repleta de perogrulladas; contradicciones y errores. He pasado largo tiempo que no le he escrito; mi ultima carta fué alterada para proteger a un personaje publico. Ahora no lo hago porque me veo forzado a reaccionar en contra del ataque vicioso, maligno y rencoroso, dirigido al Sr. Herman Baca por Linda Cross. Quiero responder ciertos puntos del articulo los cuales no creo deberan pasar sin ser contestados.

Como soy residente de National City, el Sr. Baca ha hablado por mi y por muchas otras personas, y el nunca ha asumido ninguna actitud publica sin antes haber convocado una junta de la comunidad para informarles sobre las cuestiones y actividades, y obtener sus opiniones y direccion sobre los asuntos.

Nosotros estuvimos presentes a casi todas las juntas concernientes a la zonificacion del lado este, convocadas por la Agencia de Desarrollo, (Redevelopment Agency). Muchos residentes asi como el Sr. Baca hablaron sobre los varios problemas. La unica reaccion que tuvimos de parte de la Administracion de la Ciudad fue la de someter dichos problemas a los electores de National City. Debido a la "buena" organizacion del control de votos por Morgan, y la informacion oblicua de su periodico, la proposicion para una nueva zonificacion del lado este (West side) fue derrotada. Sobre la cuestion del asesinato del Sr. Tato Rivera el Sr. Baca asi como otras personas asumieron una situacion potencialmente muy peligrosa pero presentaron un frente por el cual una, comunidad enfadada, pudiera expresar su desengaño de una manera no violenta. El hizo esto en un tiempo en que los oficiales de la ciudad no hicieron nada para aliviar la situacion. Es más, el Sr. Baca y su grupo hizo mucho para contrarestar esfuerzos y alegaciones provocativas hechas por el alcalde y miembros del concilio y otros oficiales.

La actitud racista de la Sweetwater High School y sus oficiales se notan atraves de toda la comunidad. Las deficiencias en la educacion bilingue; la ausencia de sensibilidad de los maestros, y la poca utilizacion de los recursos existentes se demostraron por muchos años. La Sweetwater High School District ha hecho muy poco para corregir estas deficiencias.

El Sr. Baca es en verdad un agente de "cambio y mejores". Debido a sus esfuerzos y otros como él, han habido cambios beneficiosos para la comunidad. Cambios beneficiosos para la Comunidad de habla Hispana, no vendran por los esfuerzos ni bondad de los oficiales de las escuelas ni de los de la ciudad. Aquellos cambios aunque limitados, se realizaron gracias a la presion y insistencia de grupos iguales a los que el Sr. Baca representa.



DECLARATION OF CHICANO

When it becomes self-evident over a long period of time that certain specific individuals, groups, or organizations become detrimental to the progress and principles of our people and to our movement, then it becomes not only our responsibility but our duty to publicly confront and denounce the perpetrators who have committed these acts against the best interest and welfare of our community.

We the undersigned of this declaration which comprise the major Chicano organizations of San Diego County hereby declare to our communities and our people that:

(1) We accuse the Socialist Workers Party (SWP) and the Young Socialist Alliance (YSA) of violating the Chicano Community's sacred principle of "self determination" by: (a) Disrespecting the political positions of Chicano Community Organizations. (b) Calling Chicano individuals and organizations to a community meeting under false pretense. (c) Using Chicano individuals and organizational names under false pretense and without their permission.

(2) We accuse the SWP of attempting to undermine the confidence of the Chicano Community to further their own aims at the expense of our people by the above acts.

(3) We accuse the SWP of using devisive actions designed to attempt to discredit and subvert the local Chicano leadership of San Diego County by labeling them violent, reactionary, and revisionist.

(4) We accuse the SWP of continually ignoring the request of the Chicano Community through the organizations to cease in their attempts at manipulation and co-optation of issues which effect our communities.

(5) We accuse the SWP of acting in a patronizing, opportunistic manner, and with a colonialist mentality which presumes that the Chicano Community is incompetent and incapable of determining its' own destiny.

Therefore, let it be known here and now and by all, that we the undersigned condemn the Socialist Workers Party and their affiliate the Young Socialist Alliance, not for their philosophy or ideology, which they have a right to, but for the unprincipled political acts which have principled political acts which have been carried out against the San Diego County Chicano Community. We hereby, also declare that because of these acts we will not work with, support or will we allow the SWP or the YSA to participate officially with our organizations or with any of our activities here in San Diego County.

(Editor's Note: On September 27, over 50 persons representing various Chicano organizations and communities denounced the invovlment of the Socialist Workers Party and Young Socialists Alliance in the CALL FOR ACTION conference issued by Judge Jose Angel Gutierrez of Crystal City, Texas.

The declaration does not condemn the San Antonio Conference or its principles and purpose.

This declaration was signed by Jesse Ramirez, Executive Director of the Chicano Federation and other Chicanos representing their perspective organizations and communities.)

4. Acusamos a la SWP de ignorar continuamente la suplica de la Comunidad Chicana por mediacion de sus organizaciones a que cesáran de sus tentativas de manipulaciones y adopciones de asuntos que afectan a nuestras comunidades.

5. Acusamos a la SWP DE ACTUAR DE UNA MANERA condescendiente, arrogante y oportunista, poseido de una mentalidad colonial que presume que la Comunidad Chicana és incompetente é incapaz para determinar su propio destino.

POR LO TANTO, sepan todos por la presente, que nosotros los de abajo firmantes, condenamos el Partido de Trabajadores Socialistas (SWP) y su afiliado, Alianza de Jovenes Socialistas (YSA) no por sus filosofias ó ideologias, por los cuales tienen derecho, pero por los actos politicos poco escrupulosos que se han dirigido contra la Comunidad Chicana del Condado de San Diego. Questions totally unrelated to the job which probe deeply into the personal lives of brewery employees are commonly asked, such as: What is your religion? Do you live by the rules of your religion? If not, why not? Do you believe in abortion? What is your marital status . . . single, divorced, living out of wedlock? What about your sexual habits, preferences, practices... with whom, where, when? Do you own property? Do you owe money... to whom, how much? Do you use drugs, take pills, smoke marijuana, etc., etc.

REFUSAL TO SUBMIT TO THE LIE DETECTOR TEST CAN MEAN IMMEDIATE DISCHARGE.

UNBELIEVABLE? Well, you can believe it because 1,500 brewery workers have walked off their jobs in defiance of these vicious company practices.

THE HISTORY OF MINORITY HIRING PRACTICES OF THIS COMPANY IS A MATTER OF RECORD WITH THE FEDERAL GOVERNMENT ... A "HORROR" STORY IN ITSELF.

We could go on and on by explaining in further detail the calculated method of forcing employees, regardless of their years of service, to submit to extensive physical examinations by company employed doctors. These doctors may then provide the type of medical reports desired by the Coors company to "weed out" their employees.

Yes, 1,500 brewery workers could not tolerate this kind of intimidation. They refused to fall to their knees and submit to these dictatorial practices. Instead, they walked off their jobs.

ESCUELA SANTA MONICA: THE BATTLE ISN'T LOST

La Causa Santa Monica has not died - it is more alive now than ever.

When Escuela Santa Monica was born September 12, Chicano parents knew they were putting their children's education on the line.

The parents, discontent with the educational system in the San Ysidro School District, pulled over 200 students out of the district for more than four weeks and created their own alternative school in the Villa Nueva Apartments.


Why did these parents decide to boycott the district schools?

Prior to the beginning of the school year, Chicano parents and children picketed the district superintendent for 60 days. Their grievences; bilingual education, sensitive teachers, better educational programs and questions concerning low test scores - were ignored by the district.

Regotiations on behalf of the district proved fruitless and the parents had no choice but to start their own school.

On October 11, parents, students and community leaders staged a march back to Smyre Elementary School to demand their share of "equal opportunity and education."

The Bilingual Teacher Corps Program has been developed by the San Diego Community College District, the San Diego Unified School District, and San Diego State University to recruit and train-bilingual teachers for future assignments in teaching limited-English and non-Englishspeaking students in elementary and secondary schools.

Upon completion of the AA degree, students will go on to obtain their teaching credentials at San Diego State University under a similar grant requested by the Education Department at San Diego State University.

Each Bilingual Teacher Corps student will be eligible for a stipend to offset loss of half-time employment income and to cover costs for books and transportation.

Cruz Rangel, Director of Bilingual Education at City College, said the Bilingual Teacher Corps students are integrated into regular bilingual education courses at the college.








6 months on the job.....it does not seem that long maybe because there's so much to do that we just don't have time to look at the calendar or the clock. Yes, we have seen some changes: new programs, new faces, new direction. But there is still so much to do.

As I look back at what moved me to come back to this job after a six years absence, I feel that my perceptions as well as those of a few very dedicated persons, were correct.

Yes, there was, and continues to be a great deal of frustration as to what the Federation was doing or not doing. But perhaps that frustration was a manifestation of unfulfilled hope; unmet needs, or maybe it was the frustration one feels when one sees a potentially powerful organization flounder in a quagmire of indecision, misdirection and petty politics.

Yes, there has been resistance to change. But I see this resistance slowly turning into much welcomed support. I have been tested; my motives questioned, but this is good, one should never become so pretencious, or so hung up on one's own press releases that community scrutiny becomes an effront.

Therein lies a fundamental precept that I hold up as point of reference: a point of departure for all the things that we do: we are a Community organization.

The Chicano Federation was founded to <u>Serve</u> the community, to be a <u>Catalyst</u> for community <u>Action</u>, to be a <u>Voice</u> for the community, and to be a central point for the community to organize on specific issues.

From this fundamental precept rises the Federation's operating mission; to <u>organize</u> the community; to <u>provide</u> <u>services</u> to the community and to <u>advocate</u> for the community.

The reorganization of the Board of Directors; the reorganization of the staff structure, the redistribution of space at the Central office; all are done with but one purpose in mind; to better serve the community. Within the framework of this overall reorganization,

other events are going to occur, new methodologies will be implemented, new concepts will be introduced.

A concept of major importance is that of accountability. On October 29, more than 1,000 persons marched from San Ysidro's Larson Park to the International Border, in support of a list of demands to the Carter Administration. The demonstration was sparked because of recent KKK activities along the U.S./Mexican Border.

CHICANOS LIST DEMANDS TO CARTER ADMINISTRATION

The recent announcement of the Ku Klux Klan leader David Duke to patrol the International Border has sparked the Chicano community to draw a list of demands to the Carter Administration.

On October 23, Grand Dragon, David Duke and ten other local Klansmen met with Immigration and Naturalization officials at the San Ysidro custom station to announce plans to patrol the border area in search for "illegal aliens."

The Klan members were greeted at the border by INS District Director, James O'Keefe and Alan Clayton, Director Support. The Klansmen were given a tour of the border by the two INS officals.

At a press conference held at the Chicano Federation, October 2**5**, Herman Baca, spokesperson for a coalition of Chicano and Black organizations dennouced the KKK's welcome by INS officials and the Carter Administration's immigration policy.

"We are here to speak out against the intrusion of extremist, racist, terrorist and vigilante groups into an already tense situation at the United States -Mexican Border, who evidently have the tatic approval of the INS/Border Patrol," said Baca.


Baca read out a list of demands which include:

1. The immediate removal of O'Keefe and Clayton.

- 2. An immediate congressional investigation of the whole border situation.
- 3. An immediate meeting of the Carter Administration with those most affected by the issue.
- 4. An immediate disavowal from the Carter Administration of INS implied support of extremist, racists groups.
- 5. An immediate telegram, incorporating these demands, and baring the signatures of all the responsible leaders of the state and nation, will be sent to President Carter.

Baca said they would hold the Carter administration responsible for its failure to comprehend the problems of Latin Americans in migration, execpt in control or containment.

"We charge the Carter Administration with failure to produce an effective immigration policy which is just, reasonalbe and humane. We hold Lionel Castillo, Commisioner of the INS to blame for the current situation for his failure and inability to control the operations of the INS, Border Patrol, or its' officials in the field."

"Finally, we hold accountable the local police, politicians and media, who through their manipulation of a serious issue have contributed to the present hysteria surrounding the undocumented alien issue," said Baca.





Does it mark the successful end of another step in an upward climb? Or a too rapid slippage in a declining career?


Can we happily count all the new friends we've made? Or do we ponder at how few we have left?

JANUARY. For the Unification of Families: The Chicano Federation asks that President-Elect, Jimmy Carter, grant admesty to all persons living in the U.S. who do not have visas.

FEBRUARY. The Chicano Federation Goes County-Wide. Meetings and elections take place in an effort to re-organize the Board of Directors and to allow equal representation to all the Chicano communities of San Diego.



MARCH. <u>A New Director is Selected</u>. After six years, Jesse Ramirez, returns to the Chicano Federation as the new executive director.

APRIL. Chicano Park Day, 1977. Thousands gather underneath the San Diego-Coronado Bay Bridge where the Mestizo flag de Aztlan was raised to commemorate the take over of Chicano Park seven years ago.



MAY. County Lawsuit: Judge Signs Consent Decree. A federal judge enters a consent decree on behalf of the Chicano Federation involving an employment discrimination lawsuit against the County of San Diego.

Castillo Visits the Federation. The Chicano Federation hosts a reception for Lionel Castillo, Commissioner of the Immigration and Naturalization Service.

JUNE. Grand Jury Accuses Supervisors.... The County grand jury accusses the Board of Supervisors of "blunders" and "politically naive and administrative actions" in its attempts to fire the director of the Equal Opportunity Management

office by abolishing the agency. Later, a district judge orders the Supervisors to rehire Victor Nieto as director of the EOM.

Kiosco Under Way. Construction begins for a kiosco in the middle of Chicano Park.

JULY. Barrio Renovation Team On The Move. The Chicano Federation starts a new program to help low-income families and Senior Citizens in Barrio Logan. The Barrio Renovation team gives Seniors much needed help around their homes and gives Barrio Logan a "new look."



AUGUST. CCR, Federation Speak Out Against the Carter Plan. Herman Baca, Chairman for the Committee on Chicano Rights and Jesse Ramirez, Director of the Chicano Federation, speak out against the Carter Immigration Plan and label it "unworkable and inhumane."

<u>1st Chicana Conference; North County</u>. The North County Federation holds its' first successful Chicana Conference in North County. Workshops, speakers and panel discussions made the day a very educational one.

Boycott Coors! Local Chicano groups protest the state-wide LULAC Convention and guest speaker William Coors at the Town and Country Hotel.

SEPTEMBER. Escuela Santa Monica. Chicano parents and children boycott the San Ysidro District Schools in a dispute over a list of demands and set up their own alternative school: Escuela Santa Monica.



OCTOBER. Reverse the Bakke Decision. More than 4,000 Chicanos and Third World people march through the streets of San Francisco to protest the racist Bakke Decision. The U.S. Supreme Court began hearing the Bakke Case this month.

International Unity March. Fifteen hundred persons march to the International Border in support of a list of demands to the Carter Administration. The demands denouce Carter's Immigration Plan and call for the removal of two local INS officials who allowed KKK leaders to tour the U.S./Mexican Border.

DECEMBER. Annual Barrio Run. Hundreds participate in the V Annual Barrio Run sponsored by the Chicano Athletic Association. The event attracted runners throughout the county. <u>Centro de Servicios</u>. A new program, Centro de Servicios legales y Sociales begins at the Federation. This program will provide services to Senior Citizens and persons seeking legal or social help.

Chicanos Oust Socialist Workers Party. Over 50 persons representing various Chicano organizations and communities declare their right to Chicano Self-Determination and denouce the involvement of the SWP in their communities and activities.

But, its primary function is to develop a centralized skills bank for efficiency, to be utilized by all spectrum in the employment arena, the unemployed, the employment agencies/systems and the employers of San Diego County.

This bank of the human resources is a step in the right direction in informing our unemployed communities pf the availability of jobs commensurate with their skills and experience and directing them to apply within the allowed time frame. Too often job openings have closed before qualified individuals were aware of their existence.

The CHAMBA Skills Bank continues to provide intake counseling and referral to employ-D ment services. The Employment Development Department (EDD) through the efforts of Mr. D) Al Mendoza, Regional Manager, has played a tremendous supporting role in the development of CHAMBA and continues to assist the Chicano Federation and the people we serve on the intake and referral process through the State Job Bank.

CHICANO ECONOMIST NAMED TO HEAD U.S. - LATIN AMERICAN COMMISSION

WASHINGTON, D.C., Nov. 8 ---Appointment of Benjamin Fernandez of Calabasa, Calif, as chairman of a fact finding commission to study Inter-American relations between the United States and selected Latin American countries was announced here today by the Institute for American Relations.

The commission, which will be called the Fernandez Commission, will meet with the heads of states and officials from the private sector, to discuss and study existing problems and recommend proposals to improve relations between the U.S. and Latin American countries.

Fernandez, who is an economist and management consultant with offices in Chatworth in suburban Los Angeles, said that subjects discussed will include economic and educational development, the Panama Canal treaties, human rights and military aid.

"Countries to be visited include Argentina, Brazil Chile, Colombia, Guatemala, Mexico, Nicaragua and Uruguay," said Fernandez. "We want to meet people with and listen to Latin American leaders and report on their hopes, aspirations and attitudes toward the United States."

According to Fernandez, findings of the commission will be submitted to the U.S. Congress and released to the news media in the U.S. and Latin America."

SWEETWATER DISTRICT GUILTY!

The Sweetwater Coalition received some good news on December 19, 1977. The news came in the form of a decision from the Office of Civil Rights (OCR) that the Sweetwater Union High School District was in non-compliance with title VI of the 1964 Civil Rights Act which prohibits discriminatory practice.

The coalitions' efforts to bring about "quality" education for the "minority" community was begun earlier this year (1977) after numerous complaints were received from concerned parents, students, teachers, and administrators. The complaints ranged from lack of hiring minority teachers, inadequate bilingual-bicultural programs, insensitivity on the part of teachers and administrators, the loss of \$600,000 of ESSA funds, inoperable Affirmative Action program, the high drop-out rate and the lack of compliance in the misuse of Federal monies. An investigation was carried out by the coalition to confirm these complaints and it was revealed that they were legitimate and valid.

At a subsequant meeting with School District Superintendent Earl Denton, no progress was made, when Denton refused to accept the coalitions complaints. According to Denton, there was no discrimination and that as far as he was concerned, all things in the district were satisfactory.

Although the coalition members have claimed a "significant victory" in their efforts to obtain quality education for the "minority" community, which now comprises 47% of the school district, they intend to continue with the lawsuit against the district.

Along with the filing of a class-action lawsuit, the coalition also intends to: a) Monitor compliance in all areas effecting educational and financial priorities as established by the Board of Trustees and the district. b) Investigate all administrative personnel including Supt. Denton and all school principals to ascertain their competence. c) Oversee and review the development, adoption, and implementation of a workable plan which will insure a quality education for all students.





Dynamic Womanhood!! Introducing Irma Castro:

In mid 1979 a new director took the lead at the Chicano Federation. She's Irma Castro, born and raised in Logan, now living with her two children in Shelltown. She had a rather interesting life as a child growing up in a family where the adults were workers involved in organizing the union for the canneries. Since a very early age she was taken to union meetings where she had her first taste of community work. She went to school locally all the time working in the community as well as the old Neighborhood House. In 1961 she became involved with political campaigns for Chicanos. She was a volunteer in various agencies in 1968 and participated in publishing a small newspaper known as "La Verdad" which she recalls with amusement. She was the first board secretary for the Chicano Federation before it became incorporated. She left San Diego in 1969 to attend La Raza Studies at Fresno State University and was there part of Fresno County Community Action. After one-andone-half years she came back to San Diego under the Pep Program to work for the "Escuelita," which was an attempt to provide family concepts in education. Four years went by during which she had her two children while teaching at San Diego State University and volunteering her time in the community. She left San Diego again in 1976 to be a research fellow at M.I.T. in Boston at the Department of Urban Studies and Planning for one year. Then back in San Diego and teaching at San Diego State University and more volunteering. She arrived with us July 30, 1979. Welcome, Irma!

Irma believes that the skills that one possesses should be put to the service of the community to which that person belongs, not her/his own. She believes that the community should not be the source to meet our needs. She feels that all learning process is education, that living is part of that process and that experience and how it's used to better one's own community is the key. She believes that we're all here to assist others achieve their goals not do it for them. We're here to assist others develop their own resources.



A View On Youth ...

The Chicano Federation has the view that the problems of youth violence lies not so much on specific incidents that are emphasized by the media but that no emphasis is made in terms of government. The issue is how to focus on youth in ways that will change the situation. The truth is that because it deals with the segment of the population which is under 18, meaning that they don't go to the polls to vote, no legislation is coming through that would alleviate the problem. However, the problem is that there's a great deal of frustration among the youth who find no jobs available and no programs that would keep them off the streets. No one has undertaken the introduction of legislation that would help youth be the future of America and in this coming election it's not likely to happen.

C.F. will be participating in the Community Congress on Youth Advocacy starting next month!! In House Training of Employees of the Chicano Federation

A series of workshops are taking place at the Federation that will make it easier for it to function. Training is being provided to the staff by the State Office of Economic Opportunity, the Nacional Concilio de America and National Council of La Raza. Their purpose is to aid the Federation in implementing systems that will fit all the functions together in more efficient ways. Experts from the above organizations have led some of the training sessions, to mention Mr. Jose Flores, OEO, Mr. Miguel F. Barragan, NCA, and Mr. Juan T. Cepeda, National Council of La Raza.

Aside from training, the C.F. is also redefining its scope. The same issues are still valid; housing, economic, equal rights, etc. But is the Chicano Federation's focus only on Chicanos? No. Other Latinos are served also in the agencies as their socio-political conditions, in general, are the same!

What community development means . . Here at the Chicano Federation it means organizing critical services to

address tenant rights, consumer protection and civil rights for Chicanos/ Mexicanos.

It could mean progressing the Latino community's positive image by becoming involved in broader city voluntary boards, like citizens planning groups, health or housing groups. It could also mean participating in specific events put on by other ethnic minorities or coalition of these groups. Also, it could mean directing or counseling graduating Chicano students to use their skills to develop their own pfrticular communities.

Rather than selecting one of the above explanations of community development, the Chicano Federation is affirmatively moving in all those directions, but based on a priority system.

In addition, the Chicano Federation is a clearing house for information on just about any social issue that one can imagine.

The Legal Services Department at the Chicano Federation is comprised of five very busy people; three paralegals, one VBS (Very Busy Supervisor), and a Rock. A Rock is personified by Luz. E. Moreno, the secretary, who is the first to deal with all the incoming legal woes an well as maintaining the steady flow of correspondence issued from this department.

The legal department sees clients by appointment only on Mondays, Wednesdays and Fridays from 9 a.m. to 11:30 a.m., and on Thursday evenings from 5 to 7:30 p.m.

The problems brought to this office range from persons with neighbors with overextended sprinkler systems (this can really dampen a good friendship) to those who have been cheated out of wages or discriminated against because of their race. Unfortunately, this office is not equipped to handle all problems; discrimination and criminal matters being two examples. However, we can assist in the following areas:

- 1. Landlord and Tenant Problems
- 2. Consumer
- 3. Social Security Hearings
- 4. Car Accidents
- 5. Employment Hearings
- 6. Small Claims Matters

The legal staff is assisted and supervised by various attorneys and other Legal Aid agencies in the community.
