Regarding Informal Complaint No. 625 of insufficient pressure in Normal Heights.

The complaint states that pressure is so low that protection from fire can not be obtained.

Normal Heights is unincorporated territory and has so far as I can determine no fire department whatever. This Company has never been asked to furnish water for fire protection. There are no fire hydrants installed, the only street hydrants being some of 2 inch size which were placed to furnish water for street sprinkling wagons.

Pressures in Normal Heights are sufficient for domestic purposes and it is obviously not up to this Company to furnish sufficient pressure for fire protection unless such demand is made upon the company and payment for such increased pressure and service.

Regarding low pressure in Normal Heights complained of to R. R. Commission.


The lot where the pressure was claimed to have been low, is situated on 42nd Street about 450 ft. south of the main on Adams Ave. which supplies all of Normal Heights. This is a 6" cast iron main and the pressure at point of connection of the 2" line on 42nd, which supplies the complainant, is 46#. The pressure at the point complained of was 41#.

In addition to the supply from the 6" line above referred to, there is a small section of Normal Heights about three sparsely settled or built up blocks which has an additional feeder consisting of a 3" line on Mission Drive to 44th St., then a 2" line on Madison Ave. to 42nd St. connecting with the line running south from the 6" line on Adams Ave. The complainants property is included in the area thus served. A glance at the maps will show you that the service in this section is the best of our entire system.

Further, should the pressure drop to 15 or 18# in this section, fully 50% of our consumers in Normal Heights would be entirely out of water and should it drop to a point as low as the R. R. Commission's letter would indicate, at least 80% of the consumers would have no water.

The complainant's property is lower than 90% of the use supply in Normal Heights, is 3/4 mile nearer the main source of supply (14" pipe on Cajon Ave.), is the only section having two feeders, is very sparsely built up (only 4 consumers on line supplying line) and as we have received no complaint from any source but


this, not even from sections 3/4 mile out on single line and at much higher elevation. I conclude that the complainant is some one with a "grouch" or that there is something the matter with his plumbing.

If these complaints are made to any of our men in Normal Heights or to the town office or to me, they are investigated and the condition remedied long before a complaint could reach San Francisco by mail.

There was no one at home when I made the investigation.

I have been unable to trace this matter down and find that there was any great reduction in pressure in the Normal Heights District during any portion of June although it may be that there was some temporary inconvenience during the time that the City's mains were being lowered in East San Diego.

It may, therefore, be that during a time of demand upon the Cuyamaca Water Co. by some portion at least of the City of San Diego a temporary condition existed, and that the matter has now been remedied ...

Will you please let us know whether this inference has any basis in fact, and also what you learn of service conditions at the address given. This is not stated to be the point wherein sufficient service was received.

Gontlemen: -

Imr letter of June 24th referring to complaint from a consumer in the Normal Heights District, has been received. This complaint alloges that the Cuyamaca Water System does not provide sufficient water pressure, that there is practically no supply for use on lawns and gardens and that there is no fire protection.

Without specific information as to the locality. it will be impossible for us to comply with your request for an investigation as to pressures which are maintained in this District. The Normal Heights section covers several square miles and it would be an undertaking of considerable magnitude to secure pressure tests all over the District.

The pipe lines in Normal Heights and in Kensington Park were practically entirely rebuilt in 1913 and 1914 and a new 16 and 14 inch line was put down El Cajon Ave. from Eucalyptus Reservoir and is connected directly with the Normal Heights system. The total cost of all this work was fully \$60,000 and unless it occurs at the end of some of the smaller pipe lines. I do not see that there can be any real criticism of the pressure supplied.

Upon receipt of additional information from you regarding locality. I will have some tests made to determine the prossure and will then write you further regarding the matter.



been received from consumers in Normal Heights regarding the quality of the water furnished and in investigation shows that the pater has a very bad odor and also contains a large percentage of moss.

The County Health Board has also taken the matter up with us by telephone and asked us to make exery effort to improve conditions.

On Saturday night the water was drained and sluiced out from the pipes in Normal Heights and Kensington Park and was turned back in time for use by consumers on Sunday morning.

We hope that this will give some relief to the consumers in this section although sufficient time has not elapsed to determine whether there will be any improvement or not. The probability being that owing to the stirring up of the sediment in all the pipes, it will be several days before conditions will settle down to normal.

I will give you a further report setting forth just how much improvement has been accomplished.
