# WHAT'S HAPPENING TO THE TEAMSTER PENSIONS?

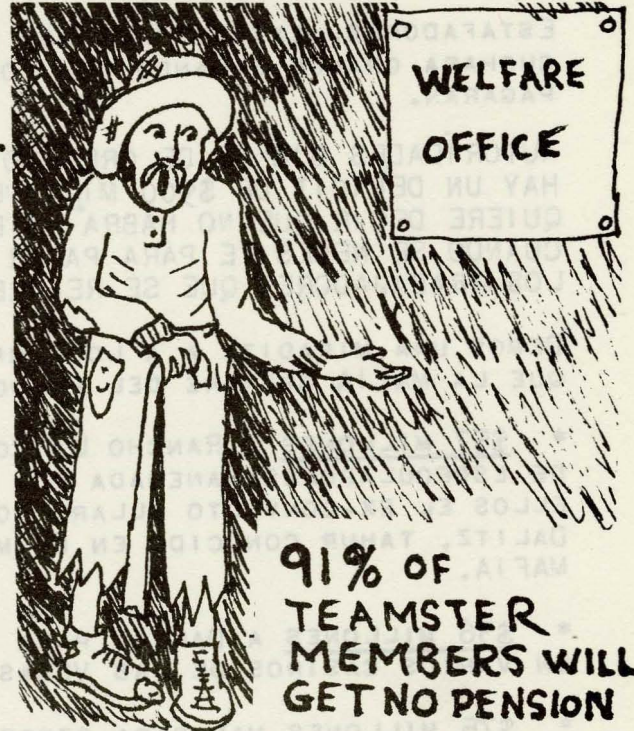
A CLOSE LOOK AT THE BIGGEST TEAMSTER PENSION FUND SHOWED THAT 91% OF THE TEAMSTERS WHOM IT COVERS MAY NEVER RECEIVE A PENSION. WHY?

CROOKS, RACKETEERS AND MAFIA MOBSTERS HAVE BEEN LABELING MILLIONS OF DOLLARS OUT OF THE TEAMSTERS PENSION FUND IN "LOANS."

SOME RELIABLE AUTHORITIES FIGURE THAT AS MUCH AS \$900 MILLION OF THE FUND MAY BE IN DEFAULT. THAT MEANS IT WON'T BE THERE WHEN IT'S NEEDED TO PAY PENSIONS TO WORKERS WHEN THEY RETIRE.

TAKE A LOOK AT SOME TYPICAL TEAMSTER PENSION FUND "LOANS":

\* \$57 MILLION TO RANCHO LA COSTA, A LAND SPECULATION OPERATION RUN BY 4 MEN INCLUDING EX-CONVICT ALLARD ROEN, AND MOE DALITZ, A GAMBLING FIGURE WITH STRONG MAFIA CONNECTIONS



## THE MAFIA GETS YOUR MONEY

\* \$45 MILLION TO A MAFIA LAWYER TO INVEST IN LAS VEGAS.

...AND THE LIST IS ENDLESS...

\* \$36 MILLION TO DALITZ SO HE COULD TAKE OVER SEVERAL LAS VEGAS CASINOS.

\* \$75 MILLION MORE TO OTHER LAS VEGAS CASINOS.

\* \$2.5 MILLION TO MAFIA BOSS ANDREW LOCOCO, SUPPOSEDLY FOR HIS COCKATOO LOUNGE AND MOTEL IN L.A.

\* \$1.1 MILLION TO "BIG MIKE" POLIZZI, ANOTHER MAFIA FIGURE.

\* \$15.5 MILLION TO GEORGE HORVATH, A CONVICTED STOCK RIGGER.

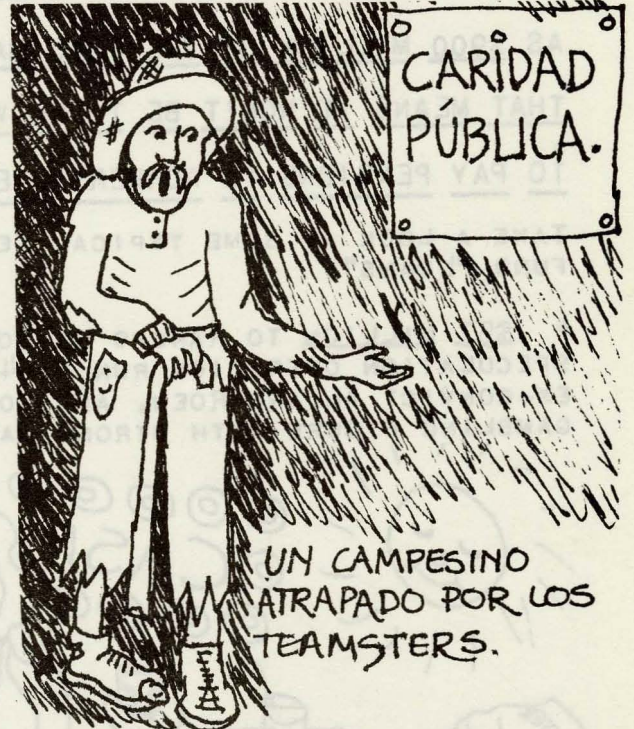

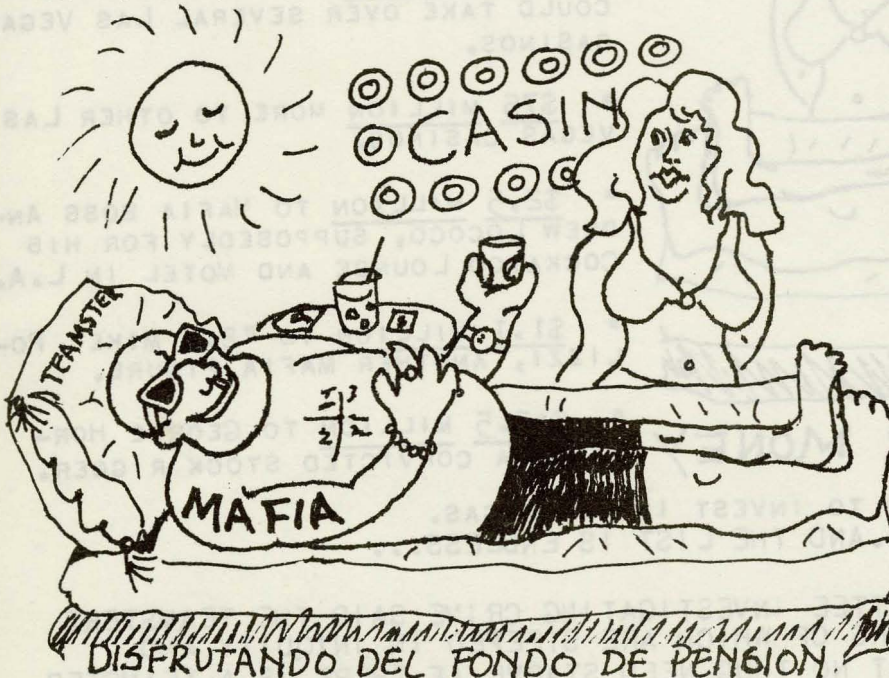
\* \$1.2 MILLONES A "BIG MIKE" POLIZZI, OTRA FIGURA DE LA MAFIA.

\* \$15.5 MILLONES A GEORGE HORVATH, CONVICTO NEGOCIANTE EN LA BOLSA.

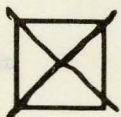
