[REDACTED] on August 11, 1975, advised that on August 10, 1975, Cesar Chavez, United Farm Workers Union, President, addressed a rally and fiesta at the Merced County Fairgrounds on August 10, 1975. This rally and fiesta was attended by approximately 1,200 persons, and they were predominantly farm workers. Chavez stated that the United Farm Workers Union now has a better chance to challenge Teamsters Union contracts because they have been granted access to Gallo winery ranches in Modesto, California, and Livingston, California.

Chavez spoke entirely in Spanish and the speech that he gave was reportedly basically the same one he had been giving during the course of a 1,000 mile walk through California.

A Merced Police Department permit for this gathering was issued for the fairgrounds from 1:00 p.m. to 7:00 p.m. The band refused to stop playing at 7:00 p.m., and Merced, California Police Sergeant [REDACTED] declared the gathering at the fairgrounds illegal after the 7:00 p.m. deadline and ordered the crowd to disperse. Cesar Chavez mounted the fairground bandstand and ordered the band to continue playing. Chavez told Sergeant [REDACTED] that the gathering was a private party and the officers had no right to break it up. After Chavez ordered the band to continue, electrical connections for the musical instruments were discontinued and police reinforcements were called to the fairgrounds to disperse the crowd. During the time the crowd was being dispersed at the fairgrounds, police officers received notification that approximately 60 to 70 United Farm Workers were gathering and demonstrating in the lobby of the Merced Police Department. During this time, a brick was thrown into a window at the Police Station and, in addition, a glass door was broken.

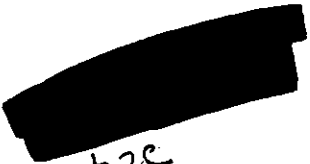

NATIONAL FARM WORKERS ASSOCIATION (NFWA)

A source, who has furnished reliable information in the past, advised on November 13, 1970, that Cesar Chavez, the leader of the National Farm Workers Association (NFWA), would be in Chicago, Illinois on November 14, 1970, to lead a picket demonstration of the National Tea Company, 740 West Diversy Avenue, Chicago, starting at 10:00 A.M., November 14, 1970, to protest the sale of non-union picked lettuce by the National Tea Company.

The source further advised Chavez would speak before Operation Breadbasket, the economic arm of the Southern Christian Leadership Conference, on November 14, 1970, to solicit the support of Operation Breadbasket of the NFWA's boycott of non-union picked lettuce.

On November 14, 1970, the weekly meeting of Operation Breadbasket was broadcast on radio station WVON, Chicago, Illinois. In this broadcast, which was monitored by a Special Agent of the Federal Bureau of Investigation, the following statements were made:

Cesar Chavez, who was introduced by Jesse Jackson, National Director of Operation Breadbasket, stated the NFWA sponsored strike against the grape growers brought a union to the farm workers. Chavez stated now the battle continues in other areas, boycotting lettuce, because these workers need the same protection that only a union can give them. Chavez stated the "poor must fight together" and called upon Operation Breadbasket to support the NFWA picket of the National Tea Company.

advised on November 13, 1979, that Cesar Chavez led a picket demonstration and rally in front of the National Tea Company, 740 West Diversey Avenue, Chicago, on November 14, 1979. The picket line was peaceful and did not interfere with the flow of individuals into or out of the National Tea Company. There were no incidents during this demonstration. The signs carried by individuals on the picket line urged the shoppers to boycott lettuce in support of the NFWA and to "Demand Union label lettuce."

A source, who has furnished reliable information in the past, advised on December 1, 1970, that the NFWA planned to picket the Dow Chemical Company, 6000 West Touhy Avenue, Chicago, Illinois, beginning at noon, December 2, 1970.

This source advised that the above picket was scheduled by the NFWA for the reasons set forth in a pamphlet captioned "Off Dow" a copy of which is attached hereto.

On December 2, 1970, [REDACTED]

[REDACTED] advised approximately twenty individuals, a number of whom carried picket signs of the NFWA, conducted a peaceful picket demonstration starting at noon, December 2, 1970, in front of the Dow Chemical Sales Office, 600 West Touhy Avenue, Chicago. The participants of this picket demonstration dispersed at approximately 2:00 PM December 2, 1970 without incident.

It is now time for a new offensive against Dow Chemical and this time the workers are leading it. In the past we have always known Dow as an oppressor of:

- the consumer - We are continually deluded with propaganda to package everything again and again.
- war victims - Dow supplies the U.S. Department of Defense with napalm, defoliants and other agents used in chemical warfare.
- 3rd world peoples - Highly poisonous herbicides and insecticides are sold on the open market in Latin America without the safety precautions indicated on the label as is required for the same products when sold in the U.S.
- the environment - Dow produces highly pollutant plastics and pesticides.

Now we discover that in addition to these offenses against the people, Dow Chemical is a leader in the oppression of migrant farm workers. 17,000 acres of lettuce owned by Dow and operated by Bud Antle, Inc. have been struck by farm workers seeking decent wages and working conditions as well as protection from dangerous pesticides. Antle is the world's second largest lettuce shipper; Dow produces many of the deadly pesticides the farm workers want outlawed or put under control. This produces a powerful bloc with which to break a strike among poor farm workers. Dow provides Antle with all his wrappers, boxes, and chemicals and lots of money. As a result Dow virtually controls Antle.

To break the farm workers' strike, Antle secured an injunction to prohibit the union, the United Farm Workers Organizing Committee, from picketing, leafletting, or talking to his employees. A similar injunction prohibits the union from boycotting Bud Antle products and in fact orders Cesar Chavez, union director, to publicly announce that people should buy Bud Antle products. Chavez has refused and so has been summoned to court December 4th to show cause why he should not immediately be imprisoned for contempt of court.

Dow has created a showdown with the farm workers who are trying to defend their rights as men. They are ready. Support the farm workers in their liberation struggle against corporate agri-business.

Boycott all Dow products. Boycott Bud Antle vegetables. Write letters of indignation to H.D. Doan, President, Dow Chemical Corp., Midland, Michigan, 48640. 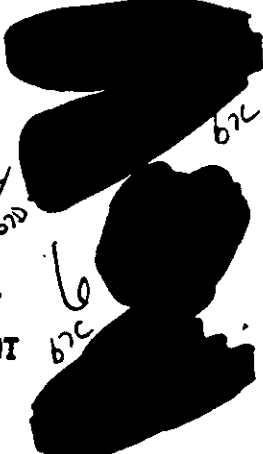

After approximately two weeks of peaceful demonstration in the Yuma, Arizona, area protesting prices paid immigrant workers, on 9/9/74 approximately 2500 individuals gathered outside Yuma city limits. Physical violence was used by groups in attempt to gain support of workers in the field. On arrival of law enforcement agencies, one of the demonstrators attempted to set fire to a stack of orange crates. Attempts to arrest suspect resulted in the assault of a Yuma County Sheriff's Deputy who was disarmed and shot at with his own weapon. No law enforcement personnel were shot, however, deputy's vehicle was hit three times. u

On September 25, 1974, [REDACTED] advised 58 Mexican males belonging to UFW were arrested by Yuma County Sheriff's Office for Unlawful Assembly near Yuma, Arizona. Arrests were made after [REDACTED] as they were in violation of a direct court order prohibiting more than 50 individuals to be assembled at one time at one locale. [REDACTED] advised local law enforcement agencies "had reached the end of the rope" and would not take any direct violations of the court orders. [REDACTED] stated that a bus used to haul workers to the fields was also burned on October 3, 1974, in Yuma. All the incidents of arson were being investigated by local authorities with no suspects developed. [REDACTED] further stated that the UFW had set up the "Wet Line" along the U. On January 29, 1973, we received a telegram from Cesar Chavez, United Farm Workers, Keene, California, which indicates possible violations of 29 U.S.C. §530 and 18 U.S.C. §241.

Chavez alleges that the offices of United Farm Workers in Delano were dynamited during the week of January 22, 1973, that their Terra Bella office in Tulare County was destroyed on January 28, 1973, and that their Poplar office was attacked recently. Chavez further alleges that Union members have been threatened with bodily harm.

We request that you conduct a preliminary investigation to determine if there has been any violations of 18 U.S.C. §241 or of 29 U.S.C. §530.

Please forward all reports in this matter to the Management and Labor Section.
