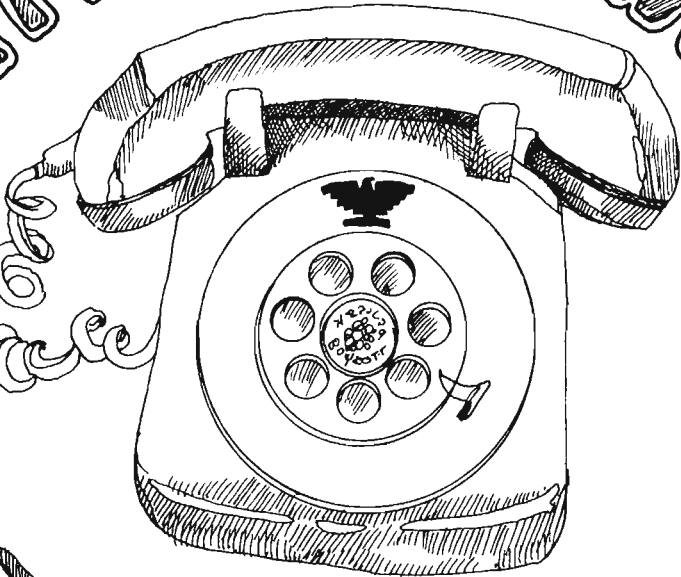



- Don't repeat your conversations unnecessarily
- Plan to make some calls during the after hours period
- Save personal calls until after 6 p.m.
- Be quick, direct and efficient

This phone book is part of that process. It is intended to enable all of us to be more effective in performing the work of the union.

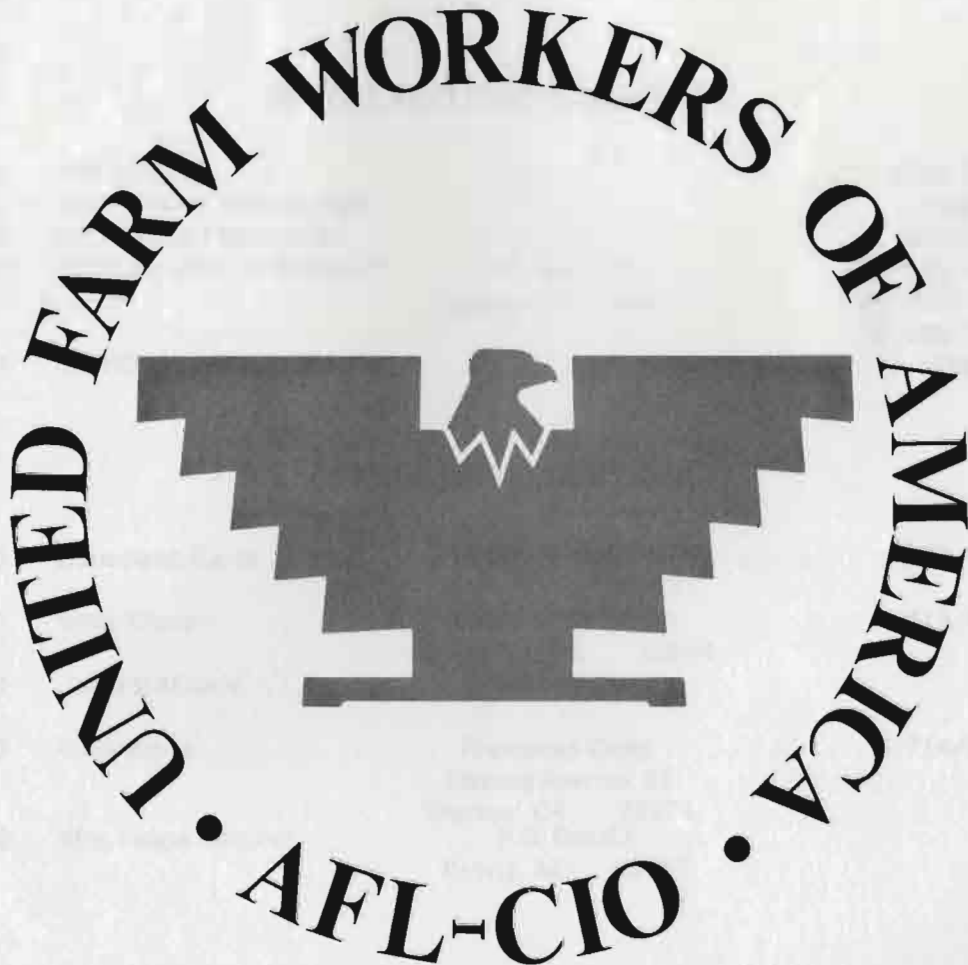

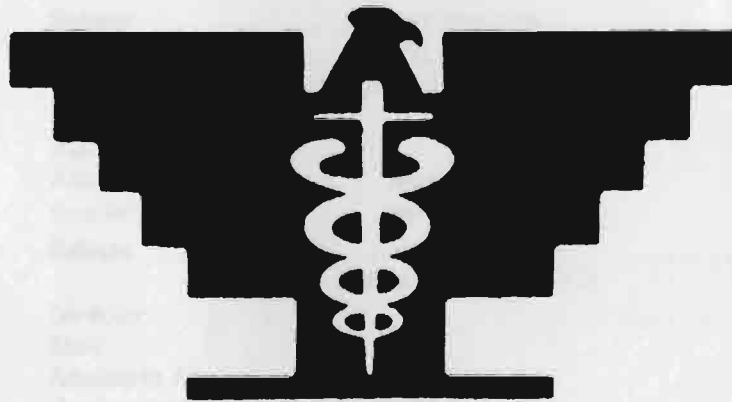
