Description: The accession consists of 33 cubic feet of records arranged in a subject classed numerical scheme. These files largely document Sea Grant under the leadership of James Sullivan (1997-1999) and Russell Moll. The files include material documenting international Sea Grant Programs, organizations, UC Systemwide activities, correspondence, and committees. The records document programs including the Marine Advisory Program, the Knauss Fellowship and the Isaacs Scholarship. The files include substantial material documenting work undertaken by Sea Grant related to legislation. The files document the relationship between Sea Grant and federal, state and local agencies including NOAA.

The National Sea Grant program was created by legislation on October 17, 1966. The goal of the legislation is to make the oceans more productive in the service of people and the nation. The University of California requested that the National Science Foundation designate the University as a Sea Grant Institution in 1970, and it received that designation on October 25, 1973. In July 1970, the University submitted a proposal to the Office of Sea Grant Programs, National Science Foundation that was funded. In subsequent years, Sea Grant funds were administered by the National Oceanic and Atmospheric Administration (NOAA). Sea Grant was part of the University of California Institute of Marine Resources until IMR closed.
